16	(a) The Wyoming council for women's issues is created

The council for women's issues shall focus 1 2 attention on the status of women in Wyoming with emphasis 3 on the following areas: 4 5 (i) Employment practices; 6 7 (ii) Educational opportunities; 8 9 (iii) Home and community; 10 (iv) Legal rights and responsibilities. 11 12 13 (b) As used in this article, unless otherwise specified, "council" means the Wyoming council for women's 14 15 issues. 16 17 9-2-602 9-12-502. Membership; term; appointments; 18 vacancies; removal; officers; acceptance of gifts and 19 donations; expenses. 20 21 (a) Effective July 1, 2000, The council shall be 22 composed of fourteen (14) members, each of whom shall serve 23 for a term of six (6) years. The governor shall make the appointments and fill any vacancies for unexpired terms. 24

1 The governor may remove any member as provided in W.S. 2 9-1-202. The council shall be composed of one (1) woman 3 from each of the judicial districts in the state, four (4) 4 persons chosen at large and the director of the department 5 of employment chief executive officer of the Wyoming business council or his designee who shall be an ex officio 6 member. Not more than nine (9) members shall be from the 7 same political party. Of the initial members appointed from 8 9 each of the judicial districts, three (3) members shall be 10 appointed for terms of two (2) years, three (3) members 11 shall be appointed for terms of four (4) years and three 12 (3) members shall be appointed for terms of six (6) years.

(b) The 14 council shall elect a chairman and 15 vice-chairman from its members. The department of employment Wyoming business council may employ a secretary 16 17 on a part-time basis to assist the council. The council may accept gifts and donations. 18

20 (c) Members of the council shall receive no 21 compensation but shall be reimbursed under W.S. 9-3-102 and 22 9-3-103 for per diem and travel expenses incurred in the 23 performance of their duties.

The members of the Wyoming council for 2 women's issues serving on the council before the effective date of this act shall continue to serve for the remainder 3 4 of their term on and after the effective date of this act, 5 except that on and after the effective date of this act, the chief executive officer of the Wyoming business council 6 7 shall serve as ex officio member in lieu of the director of the department of employment. Any employee of the council 8 for women's issues shall be transferred to the Wyoming 9 business council. 10 11 Section 3. This act is effective July 1, 2002. 12 13
