operated by the state or any of its political subdivisions, 6

7 facilitate the planning of a terrorist attack or endanger

the life or physical safety of an individual, including: 8

10 (A) Vulnerability assessments, specific

tactics, emergency procedures or security procedures 11

contained in plans or procedures designed to prevent or 12

13 respond to terrorist attacks or other security threats;

15 (B) Building plans, blueprints, schematic

16 drawings, diagrams, operational manuals or other records

17 that reveal the building's or structure's internal layout,

18 specific location, life and safety and support systems,
