- 7 **Section 1.** W.S. 15-1-402(c)(v), 15-1-403(c) and (d)
- 8 and 15-1-405 are amended to read:

- 10 15-1-402. Annexing territories; findings required;
- 11 when contiguity not deemed affected; annexation report.

- 13 (c) An annexing municipality shall prepare a proposed
- 14 annexation report as specified in this subsection. The
- 15 report shall, at a minimum, contain:

1	(v) The current and projected property taxes tax
2	mill levies imposed by the municipality; and

8	(c) The clerk shall refer the petition to the
9	governing body which, without undue delay, shall take
10	appropriate steps to within ten (10) days from the date the

14	(d) If the petition complies, the governing body
15	shall adopt a resolution certifying clerk shall certify
16	compliance, and the procedure outlined in W.S. 15-1-402,

19	action will be taken on the petition until compliance is

1 (a) In any annexation proceeding the governing body

2 shall establish a date, time and place for a public hearing

- 3 to determine if the proposed annexation complies with W.S.
- 4 15-1-402. The hearing shall be held not less than sixty
- 5 (60) thirty (30) days nor more than one hundred twenty
- (120) one hundred eighty (180) days after the effective 6
- date of the resolution petition has been certified to be 7
- 8 complete.

- 10 The clerk shall give notice of the public hearing (b)
- 11 by publishing a notice at least twice in a newspaper of
- 12 general circulation in the territory sought to be annexed.
- 13 The first notice shall be given at least twenty (20)
- 14 fifteen (15) business days prior to the date of the public
- hearing. The notice shall contain a location map which 15
- includes identifiable landmarks and boundaries of the area 16
- 17 sought to be annexed and the area which will, as a result
- of the annexation then be brought within one-half (1/2)18
- mile of the new corporate limits of the city, if it has 19
- 20 exercised the authority granted under W.S. 15-3-202(b)(ii).
- 21 The notice shall include a summary of the proposed
- 22 annexation report prepared pursuant to W.S. 15-1-402(c).
- Upon written request to the clerk of the annexing 23
- 24 municipality, the clerk shall provide a legal description

1 of the area and the names of the persons owning property

2 within the area.
