1 AN ACT relating to school buildings and facilities;

2 requiring consideration of district revenues available from

3 maximum recapture limitations for purposes of major

4 maintenance payments and for assembling school facilities

5 commission budget and financing recommendations for school

6 projects relating to such districts; and providing for an

7 effective date.

9 Be It Enacted by the Legislature of the State of Wyoming:

11 **Section 1.** W.S. 21-15-109(b) and by creating a new

12 subsection (f) and 21-15-119(a)(intro) and by creating a

13 new subsection (c) are amended to read:

14

15 21-15-109. Major building and facility repair and

16 replacement payments; computation; square footage

allowance; use of payment funds; accounting and reporting requirements; reductions for maximum recapture.

4 (b) On or before September 30 and March 31 of each

5 school year and subject to subsection (f) of this section,

6 the school facilities commission shall distribute major

7 building and facility repair and replacement payments to

8 each school district from the capital construction account.

9 Major building and facility repair and replacement payments

10 shall be computed in accordance with subsection (c) of this

11 section.

13 (f) Major building and facility repair and

14 replacement payments under this section shall be reduced

15 for any school district subject to recapture under W.S.

16 21-13-102(b) and whose revenues rebated exceed limitations

17 imposed under W.S. 21-13-102(c) due to revenues received

18 from mandatory levies per average daily membership compared

19 to statewide revenues per average daily membership. A

20 reduction under this subsection shall be applied as

21 follows:

(i) The reduction shall be implemented only if

24 maximum recapture was determined by the department of

1 education for a district in accordance with W.S. 2 21-13-102(c); 3 4 (ii) The reduction shall be imposed for any 5 fiscal year immediately following a fiscal year in which rebated revenues exceeded the maximum amount of recapture, 6 7 as established by the department for that district; 8 9 (iii) The amount of the reduction computed 10 pursuant to this subsection for any fiscal year shall be equal to the amount of the excess maximum recapture 11 determined by the department and rebated to the district 12 13 for that fiscal year. 14 15 21-15-119. Commission budget and funding 16 recommendations. 17 (a) Notwithstanding W.S. 9-2-1012 and subject to 18 subsection (c) of this section, the commission shall 19 20 annually, not later than November 1, and after review by 21 and in conjunction with the select committee on school 22 facilities, prepare and submit a recommended budget for projects and school capital construction financing to the 23 governor, through the budget division of the department of 24

1 administration and information. The recommended budget 2 submitted by the commission shall include: 3 4 (c) In preparing its annual budget under this 5 section, the commission shall for any school district for which a project has been developed by the commission under 6 7 W.S. 21-15-118 and included within its budget recommendations, consider revenues available to that 8 9 district from rebates of recapture payments computed and 10 made by the department of education in accordance with maximum recapture limitations imposed under W.S. 11 12 21-13-102(c). State funding of a maximum recapture 13 district project shall be reduced by an amount equal to the 14 rebated revenues received by that district, following reductions in major building and facility repair and 15 replacement payments under W.S. 21-15-109(f), for that 16 17 fiscal year for which the budget is authorized and approved 18 by the legislature. 19 20 Section 2. This act is effective July 1, 2003.
