## for

1 AN ACT relating to veterans; providing for free tuition at the University of Wyoming and community colleges for 2 overseas combat veterans; providing definitions; and 3 providing for an effective date. 4 5 Be It Enacted by the Legislature of the State of Wyoming: 6 7 8 Section 1. W.S. 19-14-106(a) by creating a new 9 paragraph (iii) and (c) is amended to read: 10 11 19-14-106. Free tuition and fees for education of war 12 orphans and veterans; definitions. 13 14 (a) As used in this section: 15 (iii) "Overseas combat veteran" means: 16

2	(A) An honorably discharged veteran of the
3	Indian Wars, Spanish American War, Filipino insurrection,
4	Boxer rebellion, Puerto Rico campaign or First World War;
5	
6	(B) An honorably discharged veteran of the
7	Second World War, who served in the military service of the
8	United States between December 8, 1941 and August 14, 1945;
9	
10	(C) An honorably discharged veteran of the
11	Korean War emergency, who served in the military service of
12	the United States between June 27, 1950 and July 28, 1953;
13	
14	(D) An honorably discharged veteran of the
15	Vietnam War emergency, who served in the military service
16	of the United States between February 28, 1961 and August
17	<u>15, 1973;</u>

19	(E) A widow, during her widowhood, of any
20	person qualifying under this subsection or who died while
21	serving honorably during the war, conflict or period
22	described in this section;

1	(F) An honorably discharged veteran who
2	served in the military service of the United States, who is
3	a bona fide Wyoming resident for at least three (3) years
4	and who served in one (1) of the below listed military
5	operations during the specified period and who was awarded
6	the armed forces expeditionary medal, the Vietnam service
7	medal or other authorized service or campaign medal:

9	(I) Berlin - from August 14, 1961 to
10	<u>June 1, 1963;</u>

12	(II) Lebanon - from July 1, 1958 to
13	November 1, 1958;

15	(III) Quemoy and Matsu Islands - from

13	(Homeland Security) - from October 7, 2001 to a date to be
14	determined by the department of revenue.

16	(c) The University of Wyoming and each community
17	college shall provide free tuition for not more than ten
18	(10) semesters for any Vietnam veteran <u>or overseas combat</u>
19	veteran not presently receiving education benefits under
20	the Servicemen's Readjustment Act of 1944, as amended, for
21	any credit or vocational education course for which the
22	Vietnam veteran <mark>or overseas combat veteran</mark> registers.
