7 Be It Enacted by the Legislature of the State of Wyoming:

9 Section 1.

- 11 (a) There is appropriated ten million dollars
- 12 (\$10,000,000.00) from the general fund to the department of
- 13 transportation. The funds appropriated under this act
- 14 shall be deposited in a separate account within the public
- 15 transit account created by W.S. 24-15-102.

The funds and any interest earned under the 1 (b) 2 separate account within the public transit account shall be 3 distributed to eligible grantees under the public transit 4 program created by W.S. 24-15-101, pursuant to rules 5 promulgated by the department of transportation. The department of transportation shall promulgate rules and 6 7 regulations that specify the funds within the separate account shall be used only for operational expenses and 8 9 shall not be used for capital improvements. To the extent 10 funds, including interest earned on the funds, 11 available, the department of transportation may distribute 12 funds from the separate account within the public transit 13 account to eligible grantees as follows:

15 (i) For the fiscal year beginning July 1, 2005,

16 not more than one million seven hundred fifty thousand

17 dollars (\$1,750,000.00) may be distributed;

19 (ii) For the fiscal year beginning July 1, 2006,

20 not more than one million nine hundred fifty thousand

21 dollars (\$1,950,000.00) may be distributed;

1 (iii) For the fiscal year beginning July 1,

2 2007, not more than two million one hundred fifty thousand

3 dollars (\$2,150,000.00) may be distributed;

5 (iv) For the fiscal year beginning July 1, 2008,

6 not more than two million three hundred fifty thousand

7 dollars (\$2,350,000.00) may be distributed;

8

9 (v) For the fiscal year beginning July 1, 2009,

10 not more than two million five hundred thousand dollars

11 (\$2,500,000.00) may be distributed.

13 (c) The funds distributed by the department of

14 transportation from the separate account within the public

15 transit account shall be in addition to any funds

16 distributed under W.S. 24-15-102.

17

18 (d) Effective June 30, 2010, to the extent any funds

19 remain unobligated or unencumbered in the separate account

20 within the public transit account, those funds shall revert

21 to the general fund unless the legislature extends the

22 operation of the separate account created by this act.
