In addition to the items contained in subsection 1 (d) 2 section and notwithstanding any other (a) of this 3 recommendations made by the governor, the state budget 4 shall also include the governor's recommendations for 5 appropriations for the ensuing two (2) years, or if a supplemental budget request, the remainder of the budget 6 7 period, subject to the following:

9 (i) The budget shall include state the governor's recommendations for a total appropriation from 10 11 the school foundation program account and based upon 12 recommendations of the school facilities commission under 13 W.S. 21-15-119, a total appropriation for school capital 14 construction purposes for both fiscal years. 1 (d) The state building commission shall employ a 2 secretary who shall administratively implement any rules of 3 the commission adopted under this article and perform such 4 other duties and functions of the commission as may be 5 assigned by the commission. The secretary of the commission shall be employed upon a majority vote of the commission 6 7 and serve at the pleasure of a majority of the commission. The commission shall establish compensation for its 8 9 secretary subject to legislative budget authorization. 10 9-5-106. State building commission; powers relative 11 to use of state buildings; rules authorized; exceptions. 12 13 14 the commission (b) 15 9-2-1016(b)(xxi) shall administratively implement any rules of the state building commission adopted under this 16 17 section. The director of the department of administration and information may adopt rules and regulations which make 18 19 violation of rules adopted by the commission under 20 subsection (a) of this section grounds for disciplinary 21 action for any state employee violating the rules of the 22 state building commission regarding operation, management or use of state buildings.
