## A BILL

for

1 AN ACT relating to the department of health; providing for 2 a review of the department of health; providing findings; creating a joint legislative-executive committee to review 3 4 programs and policies of the department; specifying membership and duties of the committee; specifying scope of 5 6 the review; requiring a report; providing an appropriation; and providing for an effective date. 7 8

9 Be It Enacted by the Legislature of the State of Wyoming:

11 Section 1.

13 (a) The legislature finds:

14

1 (i) That the department of health's budget has

- 2 increased significantly over the last few bienniums,
- 3 particularly in the area of health care;

4

- 5 (ii) The current budget review process within the
- 6 executive branch appears to be inadequate to assess the
- 7 increasing costs and determining an accurate forecast for
- 8 budgetary planning;

9

- 10 (iii) A joint legislative-executive committee
- 11 will assist the executive branch in a review of the
- 12 department of health's expenditures and fiscal
- 13 administration.

14

- 15 (b) There is appropriated from the general fund to
- 16 the legislative service office seventy-five thousand
- 17 dollars (\$75,000.00) to be used to establish and support a
- 18 joint legislative-executive committee to review the
- 19 governor's fact-finding report and recommendations, dated
- 20 October, 2004, with respect to the department of health's
- 21 fiscal policies and administration, and to conduct a
- 22 follow-up review of the issues presented in that report and

23 related issues.

(c) The committee shall consist of eleven (11) 1 2 members, including: 3 4 (i) Three (3) members of the Wyoming house of 5 representatives, with not more than two (2) members from the same political party. The members shall be appointed 6 7 by the speaker of the house, who shall also appoint one (1) of the members as cochairman of the committee. One (1) 8 9 member each shall be from: 10 11 (A) The house labor, health and social 12 services committee; 13 The house appropriations committee; 14 (B) 15 16 members of the (C) Among the house 17 management audit committee. 18 19 (ii) Three (3) members of the Wyoming senate, 20 with not more than two (2) members from the same political 21 party. The members shall be appointed by the president of 22 the senate, who shall also appoint one (1) of the members as cochairman of the committee. One (1) member each shall 23 be from: 24

1 (D) One (1) member who is employed in the 2 governor's office. 3 4 (d) Members of the task force shall be paid as 5 follows: 6 7 (i) Legislative members of the committee shall be paid salary, per diem and travel expenses as provided in 8 9 W.S. 28-5-101 for their official duties as members of the committee; 10 11 12 (ii) State employees serving on the task force 13 shall receive no additional compensation for serving on the task force, but shall be paid as provided in W.S. 9-3-102 14 and 9-3-103 for travel and per diem expenses incurred for 15 their official duties as members of the task force; 16 17 18 (iii) All other members of the task force shall be paid as provided in W.S. 9-3-102 and 9-3-103 for travel 19 20 and per diem expenses incurred for their official duties as 21 members of the task force. 22 (e) State agencies shall provide information 23 24 other support to the committee as requested. The

- 1 legislative service office shall staff the committee. The
- 2 committee shall meet as often as necessary and shall report
- 3 with recommendations to the joint labor, health and social
- 4 services interim committee and the joint appropriations
- 5 interim committee not later than September 1, 2005.

- 7 (f) The committee shall conduct a comprehensive
- 8 review of the department of health and all programs
- 9 administered by the department. The review shall include,
- 10 but not be limited to, review of:

- 12 (i) The fiscal accountability of the department
- 13 and its programs;

- 15 (ii) The budget accountability of the department
- 16 and its programs;

- 18 (iii) The functionality of the department's
- 19 management team to make changes necessary to accommodate a
- 20 stewardship approach to management of the department's
- 21 budget as part of the overall state budget;

- 23 (iv) The accountability and final authority of
- 24 the Medicaid program in the areas of:

21 (xv) Any other matters the committee considers 22 relevant.
