Court ordered placements of juveniles-federal funds.

A BILL

for

1 AN ACT relating to juveniles; specifying that a court shall
2 not name a provider in the court order when placing a
3 juvenile out of home if the child may qualify for federal
4 financial participation; authorizing the department of
5 family services to plan and select placement for a juvenile
6 when the juvenile is placed out of home as specified; and
7 providing for an effective date.

9 *Be It Enacted by the Legislature of the State of Wyoming:*

11 **Section 1.** W.S. 14-3-429 by creating a new subsection
12 (k), 14-6-229 by creating a new subsection (s) and 14-6-429
13 by creating a new subsection (o) are amended to read:

15 **14-3-429. Decree where child adjudged neglected;**
16 **dispositions; terms and conditions; legal custody.**

1 (k) Notwithstanding any other provision of law, if
2 the placement of a child may qualify for federal financial
3 participation under Title IV-E of the federal Social
4 Security Act, the court may direct the department of family
5 services to place the child in foster care, residential
6 care, group care or some other specific type of placement,
7 but shall not name a specific provider in the court order.
8 The court may provide to the department a list of criteria
9 the court deems necessary and in the best interest of the
10 child in making a placement decision. The selection and
11 placement of the child with a specific provider shall be
12 performed by the department of family services.

14 **14-6-229. Decree where child adjudged delinquent;**
15 **dispositions; terms and conditions; legal custody.**

17 (s) Notwithstanding any other provision of law, if
18 the placement of a child may qualify for federal financial
19 participation under Title IV-E of the federal Social
20 Security Act, the court may direct the department of family
21 services to place the child in foster care, residential
22 care, group care or some other specific type of placement,
23 but shall not name a specific provider in the court order.
24 The court may provide to the department a list of criteria

1 the court deems necessary and in the best interest of the
2 child in making a placement decision. The selection and
3 placement of the child with a specific provider shall be
4 performed by the department of family services.

6 **14-6-429. Decree where child adjudged in need of**
7 **supervision; dispositions; terms and conditions; legal**
8 **custody.**

10 (o) Notwithstanding any other provision of law, if
11 the placement of a child may qualify for federal financial
12 participation under Title IV-E of the federal Social
13 Security Act, the court may direct the department of family
14 services to place the child in foster care, residential
15 care, group care or some other specific type of placement,
16 but shall not name a specific provider in the court order.
17 The court may provide to the department a list of criteria
18 the court deems necessary and in the best interest of the
19 child in making a placement decision. The selection and
20 placement of the child with a specific provider shall be
21 performed by the department of family services.
