Liens for reclamation on private lands. 13 14 15 (a) Within six (6) months after the completion of projects to restore, reclaim, abate, control or prevent 16

1 adverse effects of past coal or mineral mining practices on 2 privately owned land, the director shall itemize the monies 3 expended and may file a lien against the property with the 4 appropriate county clerk. If the monies expended result in 5 a significant increase in property value, a notarized appraisal by an independent appraiser shall be filed with 6 the lien. The lien shall not exceed the cost of the 7 reclamation work or be the amount determined by the 8 9 appraisal to be the increase in the fair market value of 10 the land as a result of the restoration, reclamation, 11 abatement, control or prevention of the adverse effects of 12 past coal or mineral mining practices., whichever is less. 13 No lien shall be filed under this section against the 14 property of any person who owned the surface prior to May 2, 1977, and who neither consented to, participated in, nor 15 16 exercised control over the mining operation which 17 necessitated the reclamation project.

19 (b) The landowner may petition the district court for 20 the district in which the majority of the land is located 21 within sixty (60) days of the filing of the lien to 22 determine the increase in the fair market value of the 23 land. The amount reported to be the increase in value of 24 the premises, but not exceeding the cost of the reclamation

work, shall constitute the amount of the lien and shall be 1 2 recorded with the lien. 3 4 35-11-1209. Contract eligibility. 5 (a) The abandoned mine land division shall not issue 6 7 a contract to any construction contractor or professional services contractor if any or surface coal mining and 8 reclamation operation owned or controlled by the 9 contractor, or by any person who owns or controls the 10 11 contractor has any: 12 13 (vii) Notice of violation under the Surface 14 Mining Control and Reclamation Act in connection with any surface coal mining operation as identified by the United 15 16 States department of interior, office of surface mining 17 applicant violator system. 18 19 Section 2. This act is effective July 1, 2005. 20 21 (END)
