- 9 **Section 1.** W.S. 31-7-102(a)(xxv), 31-7-108(a),
- 10 31-7-109(d) by creating a new paragraph (vii), 31-7-110(a),
- 11 (b), (f) and by creating new subsections (g) through (k),
- 12 31-7-113(a) by creating a new paragraph (xi),
- 31-7-117(f)(i) and (ii), 31-7-126 and 31-7-304(a)(ii)(C)

16 **31-7-102. Definitions.**

1 2 (a) As used in this act: 3 4 (xxv) "License", "driver's license", "commercial 5 driver's license", or "instruction permit" or "intermediate permit" means any a license or permit secured by a person 6 7 from the division, in accordance with this act which grants the privilege to drive or operate a motor vehicle on the 8 9 public highways, streets and roads of this state; 10 31-7-108. Persons not to be licensed; investigation 11 12 by the division. 13 14 (a) No driver's license shall be issued to any person who is under the age of sixteen (16) seventeen (17) years, 15 except as provided in W.S. 31-7-110 and 31-7-117(c). 16 17 18 31-7-109. Classes of licenses. 19 20 (d) Licensing classification plan: 21 22 (vii) Class "I2" indicates an intermediate 23 permit issued pursuant to W.S. 31-7-110(g).

3 Any person who is at least fifteen (15) years of 4 age may apply to the division for an instruction permit. 5 The division, after the applicant has successfully passed all parts of the examination other than the driving test, 6 may issue to the applicant an instruction permit which 7 entitles the applicant while having the permit in his 8 9 immediate possession to drive a specified type or class of 10 motor vehicle for a period of one (1) year when accompanied 11 by a person at least eighteen (18) twenty-one (21) years of 12 age who has been licensed as a driver for the type or class 13 of vehicle being used for at least one (1) year holds a 14 valid driver's license, who is fit and capable of exercising control over the vehicle and who is occupying a 15 seat beside the driver. This subsection does not apply to 16 17 motorcycle instruction permits.

19 (b) Any person at least fifteen (15) years of age may 20 apply to the division for a motorcycle instruction permit. 21 The division, after the applicant has successfully passed a 22 written examination and a vision test may issue to the instruction permit which 23 applicant an entitles the 24 applicant to drive a motorcycle for a period of ninety (90)

1 days without a passenger. If the applicant also passes a

2 driving test, the division may issue an instruction permit

3 which entitles the applicant to drive a motorcycle for a

4 period of one (1) year, without a passenger. The motorcycle

5 instruction permit for a person who is under seventeen (17)

6 years of age shall be subject to restricted hours of

7 operation as provided in W.S. 31-7-110(h)(ii)(B) through

10 Any person who is at least fourteen (14) years of 11 age and who has applied and been approved for a restricted 12 license under W.S. 31-7-117(c), shall apply to the division 13 for an instruction permit. The division, after applicant has successfully passed all parts of 14 examination other than the driving test, may issue to the 15 an instruction permit which entitles 16 applicant the 17 applicant while having the permit in his possession to drive a class "C" motor vehicle for a period 18 19 of sixty (60) days when accompanied by a person at least eighteen (18) twenty-one (21) years of age who has been 20 21 licensed as a driver for a class "C" vehicle for at least 22 one (1) year holds a valid class "C" driver's license, who 23 is fit and capable of exercising control over the vehicle 24 and who is occupying a seat beside the driver.

2 (g) Any person, who is at least sixteen (16) years of 3 age and has held an instruction permit pursuant to 4 subsection (a) or (f) of this section, or in the case of an 5 applicant for an intermediate motorcycle permit an instruction permit pursuant to subsection (b) of this 6 7 section, or a similar permit from another jurisdiction and has completed practice driving of at least fifty (50) 8 9 actual driving hours, including at least ten (10) hours of 10 night driving, may apply to the division for an 11 intermediate permit that entitles the applicant to drive a specified type or class of motor vehicle. No permit may be 12 13 issued unless a parent or quardian certifies the applicant 14 has completed the practice driving requirements.

19 (i) May not transport more than one (1) passenger under the age of twenty-one (21) who is not a member of the permittee's immediate family unless 22 accompanied by a person at least twenty-one (21) years of 23 age who holds a valid driver's license for the type or 24 class of vehicle being used;

3	the hours of 5:00 a.m. and 11:00 p.m. unless:

5	(A) Accompanied by a person at least		
6	twenty-one (21) years of age who holds a valid driver's

10	evidenced by a signed statement from medical personnel;

9 31-7-126. Reporting of convictions and failure to 10 appear by courts.

Every court having jurisdiction under any statute of this state or a municipal ordinance adopted by local authority regulating the driving of motor vehicles, shall forward to the division within ten (10) working days from the date of conviction a record of the conviction of any person in the court for a violation of any of those laws or ordinances, other than those regulating standing or parking of a motor vehicle. Each court in this state shall also forward to the division within ten (10) working days from the date of conviction a record of the conviction of any person under nineteen (19) years of age in the court for a violation of any law regarding the possession, delivery, manufacture or use of a controlled substance or alcohol. The court shall

1 also forward to the division a report of any violation by

2 any person of a written promise to appear in court as given

3 to the arresting officer upon the issuance of a traffic

4 citation and any failure to appear in court at the time

5 specified by the court. Failure of a court to forward a

6 record of conviction or violation under this section within

7 the time specified in this section from the date of

8 conviction or violation shall not affect the division's

9 authority under this act.

13 (a) Commercial driver's licenses may be issued with 14 the following classifications and endorsements. The holder

15 of a valid commercial driver's license may drive all

16 vehicles in the class for which that license is issued and

17 all lesser classes of vehicles except motorcycles and

18 vehicles which require a separate endorsement, unless the

19 proper endorsement appears on the license:

22 are special authorizations permitting the driver to operate

4 (C) "P" authorizes the driver to operate a

5 bus or any motor vehicle as defined in W.S.

6 31-7-102(a)(iii) used for the transportation of passengers,

7 providing the licensed driver has attained the age of

8 eighteen (18) years; rexcept the "P" endorsement may be

9 placed upon the license of a licensed driver between the

10 ages of sixteen (16) and eighteen (18) years who has

11 secured the approval of the school district and the

12 permission of a parent or guardian of each child to be

13 transported, thereby allowing the driver to transport

14 students to and from school;

16 **Section 2.** W.S. 31-7-108(b)(vii) is repealed.

18 Section 3. This act shall only apply to persons

19 applying for a license or permit who are under the age of

20 seventeen (17) on September 16, 2005 and who do not have a

21 valid driver's license from this state or another

22 jurisdiction.
