- 1 AN ACT relating to agriculture and animals; providing for
- 2 the registration of livestock dealers; providing for
- 3 enforcement; and providing for an effective date.

5 Be It Enacted by the Legislature of the State of Wyoming:

7 **Section 1.** W.S. 11-22-118 is created to read:

8

- 9 11-22-118. Registration of livestock dealers;
- 10 records.

11

- 12 (a) Livestock dealers shall be registered with the
- 13 board. Registration shall include the livestock dealer's
- 14 address, phone number and premise identification number of
- 15 their place of business if available.

2 (b) A livestock dealer shall maintain records as

3 required by the board.

4

5 (c) After giving due notice and opportunity for

6 hearing, the board shall have the authority to deny an

7 application for registration or to suspend or cancel the

8 registration of a livestock dealer if:

9

10 (i) There is adequate evidence to establish the

11 livestock dealer had intent to violate or circumvent the

12 record keeping requirements of this section or other animal

13 health regulations; or

14

15 (ii) The livestock dealer has repeatedly

16 demonstrated an unwillingness to keep records as required

17 by the board.

19 **Section 2.** W.S. 11-1-103 and 11-22-101(a) by creating

20 new paragraphs (iv) and (v) and by amending and renumbering

21 paragraph (iv) as (vi) are amended to read:

23 11-1-103. Penalty for violations.

1 A person who violates any of the following sections commits 2 a misdemeanor punishable by imprisonment for not more than six (6) months, a fine of not more than seven hundred fifty 3 4 dollars (\$750.00), or both for the first offense, or by 5 imprisonment for not more than one (1) year, a fine of not more than one thousand five hundred dollars (\$1,500.00), or 6 7 both for second or subsequent offenses: W.S. 11-6-210(a) or (f), 11-18-112, 11-19-101, 11-19-102, 11-19-111, 11-19-401, 8 9 11-20-114, 11-20-117, 11-20-229, 11-21-104, $\frac{11-22-118}{11-21-104}$ 11-22-119, 11-23-106, 11-23-207, 11-24-106 and 11-30-114. A 10 person who violates board rules promulgated pursuant to 11 W.S. 11-18-103(a)(v) shall be subject to the penalties 12 13 specified in this section. 14 15 11-22-101. Definitions; exceptions to provisions. 16 17 (a) As used in this act: 18 19 (iv) "Livestock dealer" means: 20 21 (A) Any person engaged in the business of buying or selling livestock in commerce, either for his own 22 23 account or as an employee or agent of the seller or buyer;

1 2 (B) Any person who engages in the business 3 of buying or selling livestock in commerce on a commission 4 basis. 5 6 (v) "Livestock dealer" does not include any 7 person who buys or sells livestock as part of his own bona fide breeding, feeding, dairy, meat or wool production 8 9 operation. 10 11 $\frac{\text{(iv)}(\text{vi})}{\text{"This act" means W.S. }11-22-101 \text{ through}}$ 12 11-22-118 11-22-119. 13 14 **Section 3.** W.S. 11-22-118 is amended and renumbered as 11-22-119 to read: 15 16 17 11-22-118 11-22-119. Penalty. 18 19 Any person who violates W.S. 11-22-101 through $\frac{11-22-117}{11-22-117}$ 20 11-22-118 or any rule or regulation adopted by the board 21 pursuant to this act shall be punished as provided in W.S. 22 11-1-103. 23

24 **Section 4.** W.S. 11-22-101(a)(iii)(B) is repealed. 1

Section 5. This act is effective immediately upon 2

completion of all acts necessary for a bill to become law 3

as provided by Article 4, Section 8 of the Wyoming 4

5 Constitution.
