AN ACT relating to environmental pesticide control; modifying the use of the fees collected as provided; modifying the disposition of funds; and providing for an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

Section 1. W.S. 35-7-356(d) and 35-7-369 are amended to read:

35-7-356. Registration.

(d) Every registrant of pesticides or device shall pay an annual registration fee of seventy-five dollars (\$75.00)for every product each registered. registrations shall expire on December 31 of each year, following the date of the registration, and may thereupon be renewed for successive periods of twelve (12) months upon payment of the proper fee. Funds collected pursuant to this section shall be deposited in the general fund and may be appropriated by the legislature special natural resource account in the department of agriculture which is hereby created for programs authorized by $\frac{11 - 2 - 202(a)(v)}{11 - 5 - 113}$, and $\frac{11 - 5 - 303}{11 - 5 - 303}$. and 35 7 350 through 35 7 374.

35-7-369. Disposition of funds.

All moneys received by the department under the provisions of this act shall be deposited into the treasury of the state to the credit of the general fund, excluding those funds collected pursuant to W.S. 35-7-356(d).

Section 2. There is authorized a special natural resource account in the department of agriculture for the

purpose of collecting and disbursing funds pursuant to W.S. 35-7-356(d).

Section 3. For the period beginning July 1, 2006 and ending June 30, 2008, the department of agriculture is authorized to expend not to exceed one million two hundred fifty thousand dollars (\$1,250,000.00) from the special natural resource account for purposes specified in W.S. 35-7-356. Any further requests for expenditures from this account shall be included in the department's budget request and shall be subject to appropriation by the legislature.

Section 4. This act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.
