A BILL

for

1 AN ACT relating to judicial salaries; increasing judicial
2 salaries as specified; repealing a previous time limited
3 additional compensation provision; and providing for an
4 effective date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 5-1-110(a)(i) through (iii) are
9 amended to read:

11 **5-1-110. Salaries of judges.**

13 (a) Subject to constitutional and statutory
14 provisions concerning when salaries can become effective,
15 judges of the supreme court, district courts and circuit

1 courts shall receive the following annual salaries which
2 shall be paid in equal monthly installments on the last
3 working day of the month:

5 (i) Supreme court justices shall receive an
6 annual salary of ~~one hundred eight thousand two hundred~~
7 ~~dollars (\$108,200.00) commencing July 1, 2004, and one~~
8 ~~hundred eleven thousand four hundred dollars (\$111,400.00)~~
9 ~~commencing July 1, 2005~~ one hundred nineteen thousand three
10 hundred dollars (\$119,300.00) commencing July 1, 2007;

11
12 (ii) District court judges shall receive an
13 annual salary of ~~one hundred three thousand dollars~~
14 ~~(\$103,000.00) commencing July 1, 2004, and one hundred six~~
15 ~~thousand one hundred dollars (\$106,100.00) commencing July~~
16 ~~1, 2005~~ one hundred thirteen thousand six hundred dollars
17 (\$113,600.00) commencing July 1, 2007;

19 (iii) Circuit court judges shall receive an
20 annual salary of ~~eighty-four thousand five hundred dollars~~
21 ~~(\$84,500.00) commencing July 1, 2004, and eighty-seven~~
22 ~~thousand dollars (\$87,000.00) commencing July 1, 2005~~
23 ninety-three thousand two hundred dollars (\$93,200.00)
24 commencing July 1, 2007.

2 **Section 2.** 2006 Wyoming Session Laws, Chapter 35,
3 Section 315 is repealed.

4

5 **Section 3.** There is appropriated from the general
6 fund to the supreme court four hundred sixty-three thousand
7 eight hundred eighty-one dollars (\$463,881.00) for the
8 fiscal year beginning July 1, 2007 to implement the
9 judicial salary increases authorized by this act. This
10 appropriation is intended to replace, on July 1, 2007, the
11 unexpended appropriation previously authorized under 2006
12 Wyoming Session Laws, Chapter 35, Section 315.

13

14 **Section 4.** This act is effective July 1, 2007.
