16 19-9-601. Servicemembers group life insurance premium.

- 2 The Wyoming national guard servicemembers group life
- 3 insurance premium assistance plan is established to
- 4 reimburse qualified members of the Wyoming national guard
- 5 for group life insurance premiums. The plan shall be
- 6 administered by the adjutant general in accordance with the
- 7 provisions of this article. The adjutant general shall
- 8 promulgate rules for the administration, implementation and
- 9 proper utilization of the plan.

11 **19-9-602.** Definitions.

13 (a) As used in this article:

14

- 15 (i) "Premium" means the cost of servicemembers
- 16 group life insurance determined as provided in 38 U.S.C. §
- 17 1969(a)(1);

18

- 19 (ii) "Qualified member" means an active member
- 20 in good standing of the Wyoming national guard;

21

- 22 (iii) "Servicemembers group life insurance"
- 23 means that life insurance issued to a qualified member
- 24 pursuant to 38 U.S.C., Chapter 19.

2 19-9-603. Requirements for premium reimbursement.

3

- 4 (a) Subject to legislative appropriation and in
- 5 accordance with the provisions of this article, the
- 6 adjutant general or his designee, may authorize the payment
- 7 of premiums for qualified members who:

8

- 9 (i) Have completed basic military training or
- 10 officer training unless waived by the adjutant general for
- 11 good cause shown;

12

- 13 (ii) Meet the standards for satisfactory
- 14 participation in the active Wyoming national guard at the
- 15 beginning of and throughout the entire term for which
- 16 premium is reimbursed;

17

- 18 (iii) Are committed through an enlistment
- 19 contract or other written agreement to membership in the
- 20 active Wyoming national guard for not less than six (6)
- 21 years, including initial enlistment and any previous

22 contract or contracts.

1 (b) A qualified member meeting the requirements of

2 subsection (a) of this section may receive reimbursement

3 for premiums paid by the member during the previous

4 calendar year for servicemembers group life insurance.

5 Premiums for members of the qualified member's family and

6 premiums paid or reimbursed by the United States shall not

7 be reimbursed.

8

9 (c) Reimbursement of eligible premium paid during a

10 calendar year shall be made annually no later than May 1 of

11 the following year, based upon certified payroll

12 disbursements from the federal payment authority.

13

14 Section 2. One million nine hundred thousand dollars

15 (\$1,900,000.00) is appropriated from the general fund to

16 the Wyoming military department for the purposes of this

17 act.

18

19 Section 3. No reimbursement shall be made under this

20 act for periods of service before the effective date of

21 this act.

22

1 Section 4. This act is effective immediately upon

2 completion of all acts necessary for a bill to become law

3 as provided by Article 4, Section 8 of the Wyoming

4 Constitution.
