7 **Section 1.** W.S. 11-22-118 is created to read:

- 12 board. Registration shall include the livestock dealer's
- 13 address, phone number and premise identification number of
- 14 their place of business if available.

(b) A livestock dealer shall maintain records 1 2 required by the board. 3 4 (c) After giving due notice and opportunity for 5 hearing, the board shall have the authority to deny an application for registration or to suspend or cancel the 6 7 registration of a livestock dealer if: 8 9 (i) There is adequate evidence to establish the livestock dealer had intent to violate or circumvent the 10 11 record keeping requirements of this section or other animal 12 health regulations; or 13 14 (ii) The livestock dealer has repeatedly demonstrated an unwillingness to keep records as required 15 16 by the board. 17 18 **Section 2.** W.S. 11-1-103 and 11-22-101(a) by creating new paragraphs (iv) and (v) and by amending and renumbering 19 20 (iv) as (vi) are amended to read: 21 11-1-103.
