1 be determined to exist with respect to eligibility for 2 federal home and community based waiver services for 3 persons with developmental disabilities or adult brain 4 injury under this act. Upon a finding by the department 5 that an emergency exists under this subsection, the department in accordance with its rules and regulations 6 7 shall make necessary expenditures for the recipient from the emergency contingency account established for that 8 9 Expenditures from the emergency contingency purpose. 10 account shall be limited to those services necessary to 11 provide authorized customary services as provided by home 12 and community-based waivers for persons with developmental 13 disabilities or adult brain injury in response to the 14 emergency situation until the emergency no longer exists or 15 eligibility under this act can be determined and any necessary services provided from nonemergency funding 16 17 sources. The developmental disabilities division of the 18 department of health shall submit an accounting to the 19 joint appropriations interim committee and the joint labor, 20 health and social services interim committee by October 1 21 of each year regarding total expenditures and the number of 22 persons provided emergency services pursuant to this 23 subsection.

3 purposes of (a) For the this act, there is 4 appropriated to the department of health for the period 5 commencing July 1, 2007 five hundred thousand dollars (\$500,000.00) from the budget reserve account and 6 7 federal matching funds for which the expenditures 8 qualify.

10 (b) Funds appropriated under this section shall be used only for the purposes of this act, shall not be 11 12 transferred or expended for any other purpose and shall not be expended until the adoption of final rules as provided 13 14 in section 1 of this act. Any unexpended, unobligated 15 funds remaining from this appropriation on June 30, 2008 16 shall not revert to the budget reserve account, but shall revert to that account on June 30, 2010. 17

Section 3. This act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.
