8 **Section 1.** W.S. 21-15-109(f) is amended to read:

- 12 allowance; use of payment funds; accounting and reporting

- 15 (f) Notwithstanding subsection (e) of this section, a
- 16 district may expend up to ten percent (10%) of the amount
- 17 distributed during any school year under subsection (b) of

this section for major building and facility repair and 1 2 replacement needs of the district which are not specified 3 in the district's facility plan, including expenditures for 4 maintenance of district enhancements. Expenditures shall 5 be made under this subsection only after the district's and and facility repair replacement 6 building 7 specified in its facility plan have been addressed in accordance with subsection (e) of this section and the 8 9 commission has approved the district's proposed expenditures under this subsection. Effective for the July 10 11 1, 2007 payment under this section and each payment thereafter, amounts not expended for purposes of this 12 13 subsection during any school year may be accumulated by a 14 district and earmarked within the separate account established under subsection (e) of this section for 15 expenditure under this subsection in subsequent school 16 17 years, provided the unexpended amount during any school year to be accumulated does not exceed eight percent (8%) 18 19 of the amount distributed to the district under subsection 20 (b) of this section for that school year. Each district 21 shall include expenditures under this subsection and any amounts accumulated from year-to-year under this subsection 22 within the annual report required under subsection (e) of 23 24 this section. Nothing in this subsection shall prohibit or

1 limit the application of subparagraph (c)(i)(D) of this 2 section in computing a district's building and facility 3 gross square footage for purposes of determining payment 4 amounts under this section. If any school district exceeds 5 expenditure limitations prescribed by this subsection or fails to comply with expenditure levels for facility 6 7 adequacy needs identified within its facility plan, the payments for that district in the immediately succeeding 8 9 year shall be reduced by the excess expenditure amount 10 including any excess expenditure of amounts accumulated 11 under this subsection. 12 13 Section 2. This act is effective July 1, 2007. 14
