1 shall be paid in equal monthly installments on the last 2 working day of the month: 3 4 (i) Supreme court justices shall receive an 5 annual salary of one hundred eight thousand two hundred dollars (\$108,200.00) commencing July 1, 2004, and one 6 7 hundred eleven thousand four hundred dollars (\$111,400.00) commencing July 1, 2005 one hundred nineteen thousand three 8 9 hundred dollars (\$119,300.00) commencing July 1, 2007; 10 11 (ii) District court judges shall receive an 12 annual salary of one hundred three thousand dollars (\$103,000.00) commencing July 1, 2004, and one hundred six 13 thousand one hundred dollars (\$106,100.00) commencing July 14 1, 2005 one hundred thirteen thousand six hundred dollars 15 (\$113,600.00) commencing July 1, 2007; 16 17 (iii) Circuit court judges shall receive an 18 19 annual salary of eighty four thousand five hundred dollars 20 (\$84,500.00) commencing July 1, 2004, and eighty seven thousand dollars (\$87,000.00) commencing July 1, 2005 21 22 ninety-three thousand two hundred dollars (\$93,200.00) commencing July 1, 2007. 23

1 2006 Wyoming Session Laws, Chapter 35, Section 2. 2 Section 315 is repealed. 3 4 Section 3. There is appropriated from the general 5 fund to the supreme court four hundred sixty-three thousand eight hundred eighty-one dollars (\$463,881.00) for 6 the 7 fiscal year beginning July 1, 2007 to implement judicial salary increases authorized by this act. This 8 9 appropriation is intended to replace, on July 1, 2007, the unexpended appropriation previously authorized under 2006 10 Wyoming Session Laws, Chapter 35, Section 315. 11 12

13 **Section 4.** This act is effective July 1, 2007.
