Definitions. 1 2 3 (a) As used in this title: 4 5 (iii) "Club" means any of the following organizations: 6 7 8 (G) A political subdivision of this state 9 owning, maintaining or operating a bona fide golf course 10 together with a clubhouse. 11 12 12-4-103. 7 club (g) Any golf as defined by W.S. 12-1-101(a)(iii)(D) which holds a retail liquor license or 8 9 a club limited retail liquor license under W.S. 12-4-301 10 may dispense alcoholic beverages from any location within 11 the boundaries of the golf club premises. The premises shall be a single property within a contiquous boundary 12 13 upon which the golf club is located and which shall be 14 identified in the license. Subsections (a) through (c) and (e) of this section do not apply to golf clubs as defined 15 by W.S. 12-1-101(a)(iii)(D) which are holders of a retail 16 17 liquor license or a club limited retail liquor license with 18 respect to alcoholic beverages dispensed within 19 contiguous boundaries of the golf club premises, except 20 that any location on the golf club premises where alcoholic 21 beverages are dispensed as approved by the licensing 22 authority shall comply with applicable sanitation and fire 23 hazard requirements and other applicable laws. The 24 licensing authority shall, as often as necessary, inspect

1	the licensed location where alcoholic beverages are
2	dispensed to ensure that the licensee is in compliance with
3	sanitation and fire hazard requirements. Any licensee
4	issued a club limited retail liquor license for use at a
5	bona fide golf course may contract for or otherwise
6	subcontract the operations of the golf course or any food
7	and beverage services associated therewith to another
8	individual or entity without transferring the license
9	thereto.
