for

- 1 AN ACT relating to the licensure of denturists; creating a
- 2 board of denturists; regulating the practice of denturism;
- 3 providing for licensing, fees, examinations and other
- 4 regulation of denturists; repealing prohibition on
- 5 soliciting for denturism services; providing criminal
- 6 penalties for violations of denturist act; providing
- 7 definitions; and providing for an effective date.

4	33-15-201. Definitions.									
5										
6	(a) As used in this article:									
7										
8	(i) "Board" means the Wyoming board of									
9	denturists;									
10										
11	(ii) "Denture" means a removable full or partial									
12	upper or lower dental appliance to be worn in the mouth to									
13	replace the missing natural teeth;									
14										
15	(iii) "Denturist" means a person licensed under									
16	this article to engage in the practice of denturism;									
17										
18	(iv) "Practice of denturism" means:									
19										
20	(A) Making, placing, constructing,									
21	altering, reproducing or repairing a denture; and

1	(B) Taking impressions and furnishing or								
2	supplying a denture directly to a person or advising the								
3	use of a denture and maintaining a facility for the same.								
4									
5	(b) This article may be cited as the "Wyoming Denture								
6	Practice Act".								
7									
8	33-15-202. Board of denturists.								
9									
10	(a) There is created the Wyoming board of denturists.								
11	The board shall carry out the purposes and enforce the								
12	provisions of this article. The board shall consist of								
13	five (5) members appointed by the governor with the advice								
14	and consent of the senate. Appointments made between								
15	sessions of the legislature shall be made in accordance								
16	with W.S. 28-12-101.								
17									
18	(b) The term for board members is four (4) years and								
19	shall be in accordance with W.S. 28-12-101 through								
20	28-12-103.								
21									
22	(c) The board shall consist of:								

(i) Three (3) practicing denturists;

2 (ii) One (1) practicing dentist; and

3

4 (iii) One (1) member of the public, appointed by

5 the governor.

6

7 (d) The governor may remove any member as provided in

8 W.S. 9-1-202. Any vacancy on the board caused by the

9 resignation, death or removal of a member shall be filled

10 by the governor by appointment for the unexpired term of

11 that member. Any appointment to fill a vacancy shall be

12 made within ninety (90) days after the vacancy occurs.

13

14 (e) Each member of the board shall, before entering

15 upon the duties of his office, take and subscribe an oath

16 or affirmation that he will support the constitution and

17 the laws of the United States and the state of Wyoming, and

18 that he will faithfully perform the duties as a member of

19 the board.

20

21 (f) The board shall elect from its members a

22 president, vice-president and a secretary-treasurer. The

23 board shall have a common seal. The board shall meet in

24 June each year, and more often if necessary, at such times

1 and places designated by the board. The meeting of the

2 board shall be at the call of the president and the

3 secretary-treasurer. Five (5) days notice shall be given

4 by the secretary-treasurer to all board members of the time

5 and place of the meeting. A majority of the board

6 constitutes a quorum.

7

8 (g) The board shall not create any indebtedness on

9 behalf of the state of Wyoming, except as provided in this

10 section. Out of the funds assessed by the board, each of

11 the members of the board shall receive compensation for

12 each day or part of a day in which they are engaged in

13 performance of their official duties at the same rate as

14 state legislators and shall be reimbursed for actual and

15 necessary expenses, and mileage incurred in the performance

16 of their official duties.

17

18 (h) The board shall report annually to the governor

19 respecting all activities, as required by W.S. 9-2-1014.

20

21 33-15-203. Denturists; generally.

22

23 (a) Before making and fitting a denture, a denturist

5

24 shall examine the patient's oral cavity.

If the examination gives the denturist reasonable 2 cause to believe that there is an abnormality or disease 3 process that requires medical or dental treatment, the 4 5 denturist shall immediately refer the patient to a dentist or physician. In such cases, the denturist shall take no 6 further action to manufacture or place a denture until the 7 patient has been examined by a dentist or physician and the 8 9 dentist or physician gives written clearance that the 10 denture will pose no threat to the patient's health.

11

12 (c) If the examination reveals the need for tissue or
13 teeth modification in order to assure proper fit of a full
14 or partial denture, the denturist shall refer the patient
15 to a dentist and assure that the modification has been
16 completed before taking an impression for the completion of
17 the denture.

18

19 (d) Any denturist who makes or places a denture in a 20 manner not consistent with this section is subject to the 21 sanctions provided under this article.

22

23 (e) A denturist shall successfully complete special 24 training in oral pathology prescribed by the board, whether

- 1 as part of an approved associates degree program or
- 2 equivalent training, and pass an examination prescribed by
- 3 the board, which may be a part of the examination for
- 4 licensure to become a licensed denturist.

6 33-15-204. Qualifications.

7

- 8 No person may represent himself as a licensed denturist or
- 9 use any title or description of denturism services without
- 10 applying for licensure, meeting the required qualifications
- 11 and being licensed as a denturist by the board, unless
- 12 otherwise exempted by this article.

13

14 **33-15-205.** Exemptions.

15

16 (a) Nothing in this article prohibits or restricts:

17

- 18 (i) The practice of a profession by an
- 19 individual who is licensed, certified or registered under
- 20 other laws of this state and who is performing services
- 21 within the authorized scope of practice;

22

- 23 (ii) The practice of denturism by an individual
- 24 employed by the government of the United States while the

7

1 individual is engaged in the performance of duties

2 prescribed by the laws and regulations of the United

3 States;

4

- 5 (iii) The practice of denturism by students
- 6 enrolled in a school approved by the board. The
- 7 performance of services shall be pursuant to a course of
- 8 instruction or an assignment from an instructor and under
- 9 the supervision of an instructor; or

10

- 11 (iv) Work performed by dental labs and dental
- 12 technicians under the written prescription of a dentist.

13

14 33-15-206. Determination of fees.

15

- 16 The board shall determine, in accordance with W.S.
- 17 33-1-201, each year the fees to be collected for
- 18 examinations, reexaminations, licensure and renewals.

19

20 33-15-207. Reciprocity; licensing.

21

- 22 (a) The board shall issue a license to practice
- 23 denturism to an applicant who submits a completed

1 application, pays the appropriate fees, and meets the

2 following requirements:

3

4 (i) A person currently licensed to practice

5 denturism under statutory provisions of another state,

6 territory of the United States, District of Columbia or

7 Puerto Rico, with substantially equivalent licensing

8 standards to this article applicable to denturism shall be

9 licensed without examination upon providing the board with

10 the following:

11

12 (A) Proof of successfully passing a written

13 and clinical examination for denturism in a state,

14 territory of the United States, District of Columbia or

15 Puerto Rico, that the board has determined has

16 substantially equivalent licensing standards as those in

17 this article, including but not limited to both the written

18 and clinical examination; and

19

20 (B) An affidavit from the licensing agency

21 where the person is licensed or certified attesting to the

22 fact of the person's licensure or certification.

23

(b) A person graduating from a formal denturism 1 2 program shall be licensed if he: 3 4 (i) Documents successful completion of formal 5 training with a major course of study in denturism of not less than two (2) years in duration at an educational 6 institution approved by the board; 7 8 (ii) Passes a written and clinical examination 9 approved by the board; and 10 11 12 (iii) Pays the appropriate fees. 13 33-15-208. Examinations. 14 15 The board of denturists shall administer the 16 (a) examinations for licensing denturists under this article, 17 subject to the following requirements: 18 19 20 (i) Examinations shall determine 21 qualifications, fitness and ability of the applicant to practice denturism. The test shall include a written 22 examination and a practical demonstration of skills; 23

1 (H) Asepsis; 2 3 (J) Medical emergencies; and 4 5 (K) Cardiopulmonary resuscitation. 6 (v) The applicant shall be informed in writing 7 by certified mail of the results of his examination within 8 9 thirty (30) days after the examination. An applicant who 10 fails an examination may apply to the board for a reexamination at the next scheduled examination meeting. 11 Application shall be made in writing and shall be 12 13 accompanied by a fee as provided in subsection (c) of this section; 14 15 16 applicant (vi) If the fails the board examination three (3) times, he shall show evidence of 17 additional education to the satisfaction of the board 18 before he may be reexamined. 19 20 (b) The board may hire trained persons licensed under 21 22 this article to prepare, administer and grade the examinations or may contract with regional examiners who 23 meet qualifications adopted by the board. 24

2 (c) The examination fee shall be set by the board each year, and all reexamination fees shall be the same as 3

the current fee for the initial examination. Fees shall be 4

5 paid to the secretary of the board before examination.

fee shall be paid by money order, cashiers' check or 6

certified check, and in no case shall the fee be refunded. 7

9 33-15-209. License content.

10

11 The administrative procedures, administrative (a) requirements and fees for denturism shall be determined by 12 the board as provided for under this article.

(b) The license shall contain, on its face, the 15 address and addresses where the license holder will perform 16 the denturist services. 17

18

19 33-15-210. Renewal license certificate.

20

21 The board shall establish by rule the requirement for

22 renewal of licenses to practice denturism, but shall not

increase the licensure requirements provided for denturism 23

in this article. 24

2 33-15-211. Grounds and procedure for revocation or 3 suspension of license.

4

5 (a) Any denturist may have his license revoked or 6 suspended by the board for any of the following causes:

7

8 (i) Conviction of a felony or high misdemeanor

9 involving moral turpitude, in which case the record of

10 conviction certified by the clerk or judge of the court in

11 which the conviction is had is conclusive evidence;

12

13 (ii) For renting or loaning to any person his

14 license or diploma to be used as a license or diploma for

15 such person;

16

17 (iii) For unprofessional conduct, advertising or

18 soliciting patients in any form of communication in a

19 manner that is false or misleading in any material respect;

20 or

21

22 (iv) Willful violation of any provisions of this

23 article.

24

1 (b) The proceedings under this section may be taken by the board from matters within its knowledge or upon 2 information from another. If the informant is a member of 3 the board, the other members of the board shall take action 4 5 on behalf of the board. All complaints shall be writing, verified by a party familiar with the facts 6 charged, and shall be filed with the secretary of the 7 Upon receiving the complaint, the board, if it 8 board. 9 deems the complaint sufficient, shall proceed as in a contested case under the Wyoming Administrative Procedure 10 11 Upon revocation of any license, the fact shall be noted upon the records of the board and the license shall 12 13 be marked revoked upon the date of its revocation. 14 secretary of the board, upon judgment of suspension or revocation being entered, shall transmit to the secretary 15 of state a copy of the judgment order, certified by the 16 17 secretary of the board, and the same shall be kept in the same manner as the list of licensed dentists. 18

19

20 (c) Upon receipt from the department of family
21 services of a certified copy of an order from a court to
22 withhold, suspend or otherwise restrict a denturist license
23 issued by the board, the board shall notify the party named
24 in the court order of the withholding, suspension or

1 restriction of the license in accordance with the terms of

2 the court order. No appeal under the Wyoming

3 Administrative Procedure Act shall be allowed for a license

4 withheld, suspended or restricted under this subsection.

5

6 33-15-212. Renewal license certificate.

7

(a) On or before December 31 of each year, each 8 9 denturist licensed to practice denturism in this state, 10 upon receipt of written notice, shall transmit to the 11 secretary of the board his signature and address, together with a fee determined by the board and the number of his 12 13 license, and receive therefor а renewal license 14 certificate. Any license granted by the board shall be cancelled after ten (10) days written notice sent to the 15 holder by registered mail if the holder fails to secure the 16 17 renewal certificate within three (3) months after December 31 each year, but any license so cancelled may be restored 18 by the board upon the payment of a fee as set by the board, 19 if paid by December 31 of the year in which the license is 20 21 cancelled.

22

23 (b) Commencing January 1, 2014, any denturist whose 24 application for renewal indicates that he has not actively

1 practiced dentistry or engaged in teaching dentistry for

2 any of the preceding five (5) years shall be issued a

3 renewal certificate by the board only after a hearing and

4 upon notice to the applicant, wherein the applicant

5 demonstrates to the board that he has maintained the

6 qualifications set forth in this article. No reexamination

7 is required unless the board finds good cause to believe

8 that the person has not maintained the professional ability

9 and knowledge required of an original licensee under this

10 article.

11

12 (c) The board may set continuing education

13 requirements for relicensure of denturists.

14

33-15-213. Secretary of state's certificate that no

16 license listed by board is prima facie proof of

17 unauthorized practice.

18

19 In any prosecution for violation of any provision of this

20 article the certificate of the secretary of state that the

21 person accused of the violation of any of those provisions

22 is not named in the list of denturist presented to him by

23 the secretary of the board is prima facie proof that the

24 person is not entitled to practice denturism in Wyoming.

2 33-15-214. Partnerships with dentists.

3

- 4 Notwithstanding any other provision of state law, a
- 5 licensed denturist may enter into a partnership or other
- 6 business association with a dentist, provided that the
- 7 association does not impede the independent professional
- 8 judgment of either party.

9

10 **33-15-215.** Violations.

11

- 12 Any person who practices denturism without being properly
- 13 qualified and licensed, or who violates any provisions of
- 14 this article is subject to a fine not to exceed one
- 15 thousand dollars (\$1,000.00), or imprisonment for not more
- 16 than two (2) years, or both. Each separate violation of
- 17 this article constitutes a separate offense.

18

- 19 33-15-216. List of licensees filed with secretary of
- 20 state.

21

- 22 A list of all denturists licensed under this article shall
- 23 be published by the board each year. This list shall
- 24 contain the name and address of each denturist and such

1 other information as the board deems advisable. The board

2 shall place a copy of the list on file in the office of the

3 secretary of state who shall furnish copies to the public,

4 upon request.

5

6 33-15-217. Certificate entitles denturists to

7 practice in any county; lost certificates.

8

9 The certificate provided for in this article entitles the

10 holder to practice denturism in any county in Wyoming. The

11 board, upon satisfactory proof of loss of the certificate

12 issued under this article, shall issue a new certificate.

13 The cost of replacement shall be determined by the board

14 and paid by the person requesting replacement.

15

16 **Section 2.** W.S. 33-15-116 is repealed.

17

18 Section 3. This act is effective July 1, 2009.
