1	(a) Notwithstanding W.S. 9-2-1012, The commission
2	shall annually, not later than November 1, and after review
3	by and in conjunction with the select committee on school
4	facilities, prepare and submit a recommended budget,
5	together with the annual building status report specified
6	under W.S. 21-15-121, for projects and school capital
7	construction financing to the governor, through the budget
8	division of the department of administration and
9	information select committee on school facilities. The
10	recommended budget submitted by the commission shall
11	include:

13	21-15-121. Annual school building status report to

16	(a) Not later than December 31 <u>November 1</u> of each
17	year, the commission shall submit a report to the select
18	committee on school facilities on progress being made under

9	recommendations to the joint appropriations committee and
10	the legislature including any necessary implementing
11	legislation;

13	(c) The school facilities commission shall:

16	committee upon request to assist the select committee in
17	monitoring progress under paragraph (b)(ii) of this section
18	and in reviewing budget recommendations under paragraph
