1 A JOINT RESOLUTION requesting Congress to propose an

2 amendment to the United States Constitution repealing the

3 seventeenth amendment to the United States Constitution.

4

5 WHEREAS, prior to the passage of the seventeenth amendment

6 of the United States Constitution the power to select

7 senators was held by the various state legislatures

8 pursuant to Article 1, Section 3, Clause 1 of the United

9 States Constitution; and

10

11 WHEREAS, prior to the passage of the seventeenth amendment

12 of the United States Constitution, upon a vacancy in the

13 office of a senator, the governor of a state was empowered,

14 under Article 1, Section 3, Clause 2 of the United States

15 Constitution, to fill the vacancy with a temporary

1 appointment until such time as the legislature convened and

2 selected a replacement; and

3

4 WHEREAS, upon ratification of the seventeenth amendment of

5 the United States Constitution in 1913, the power to elect

6 senators from each state was passed to the people thereof;

7 and

8

9 WHEREAS, upon ratification of the seventeenth amendment of

10 the United States Constitution in 1913, when a vacancy

11 occurred in the office of a senator, the governor of the

12 state was directed to issue a writ of election to fill the

13 vacancy provided however that the state legislature could

14 empower the governor to appoint a temporary successor until

15 the next election; and

16

17 WHEREAS, the founders of our republic and the framers of

18 the constitution recognized that in a republican

19 government, the legislative authority being necessarily

20 predominant, that it should be divided into two (2)

21 different branches composed by different modes of election,

22 creating different principles of action and as little

23 connected with each other as the nature of their common

- 1 functions and their common dependencies on society would
- 2 admit; and

3

- 4 WHEREAS, James Madison explained in the Federalist Papers,
- 5 No. 10, the reason for bicameralism: "Before taking effect,
- 6 legislation would have to be ratified by two independent
- 7 power sources: the people's representatives in the House
- 8 and the state legislatures' agents in the Senate"; and

9

- 10 WHEREAS, James Madison, in the Federalist Papers, No. 62,
- 11 wrote that "The appointment of senators by state
- 12 legislatures gives the state governments such an agency in
- 13 the formation of the federal government as must secure the
- 14 authority of the former"; and

15

- 16 WHEREAS, Alexander Hamilton, in the Federalist Papers, No.
- 17 27, concluded that because the legislatures were selected
- 18 bodies of men, the choice of United States senators would
- 19 "generally be made with peculiar care and judgment by the
- 20 legislatures"; and

21

- 22 WHEREAS, the founders of the constitution created an
- 23 ingenious template of checks and balances, with divisions

- 1 and distributions of power to provide for and protect the
- 2 highest sovereignty that of each individual citizen; and

3

- 4 WHEREAS, the seventeenth amendment of the United States
- 5 Constitution disrupts that balance of power by providing
- 6 for the selection of senators by popular vote in the same
- 7 manner representatives are selected by popular vote; and

8

- 9 WHEREAS, popular election of senators has diluted the power
- 10 of the separate states, diminished federalism and has
- 11 resulted in the increased power of the federal government
- 12 over the individual states.

13

- 14 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE
- 15 LEGISLATURE OF THE STATE OF WYOMING:

16

- 17 **Section 1.** That the Wyoming Legislature urges the
- 18 Wyoming Congressional delegation and all the members of the
- 19 United States Congress to propose an amendment to the
- 20 United States Constitution repealing the seventeenth
- 21 amendment thereof.

Section 2. That the Secretary of State of Wyoming

2 transmit copies of this resolution to the President of the

3 United States, to the President of the Senate and the

4 Speaker of the House of Representatives of the United

5 States Congress and to the Wyoming Congressional

6 Delegation.
