Subject to W.S. 35-1-107, no person 8 commence to construct a facility, as defined in this 9 chapter, in this state without first obtaining a permit for 10 11 that facility from the council. Any facility, for which a permit is required, shall be constructed, operated and 12 13 maintained in conformity with the permit and any terms, conditions and modifications contained in the permit. A 14 permit may only be issued pursuant to this chapter or 15 pursuant to the provisions of W.S. 18-5-501 through 16 18-5-513 for facilities referred to the council. 17

Section 3. This act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.
