15 **1-39-103. Definitions.**

2	(a) As used in this act:

4	(ii) "Local government":
5	
6	(A) Means cities and towns, counties,
7	school districts, joint powers boards, airport boards,
8	public corporations, community college districts, special
9	districts and their governing bodies, all political
10	subdivisions of the state, and their agencies,
11	instrumentalities and institutions;

13	(B) Includes a governmental entity of
14	another state operating a public transportation program
15	when:

17	(I) The other state has, by written
18	agreement entered in accordance with W.S. 16-1-101,
19	extended or agreed to extend its governmental immunity or
20	other limitations of liability to Wyoming for purposes of
21	<pre>public transportation programs; and</pre>

23	(II) The public transportation program
24	is operated by a governmental entity in the other state and

1 a local government in this state, as defined in

2 subparagraph (A) of this paragraph, pursuant to an

3 agreement under W.S. 16-1-101, which program includes one

4 (1) or more routes beginning in, ending in or passing

5 through Wyoming. For purposes of this subparagraph,

6 "public transportation program" means a not-for-profit

7 program designed to transport passengers to and from work,

8 or to another location on a regularly scheduled basis,

9 using vehicles operated by a governmental entity.

11 16-1-101. Authority to cooperate.

13 In exercising, performing or carrying out any power,

14 privilege, authority, duty or function legally vested in

15 any one (1) or more of them by Wyoming law, the state of

16 Wyoming, and any one (1) or more of its counties, municipal

17 corporations, school districts, special districts, public

18 institutions, agencies, boards, commissions and political

19 subdivisions, and any officer or legal representative of

20 any one (1) or more of them, may cooperate with and assist

21 each other, and like entities or authorities of other

22 states, the United States and the Eastern Shoshone and

23 Northern Arapaho Tribes of the Wind River Reservation.

24 Cooperation may be informal or subject to resolution,

ordinance or other appropriate action, and may be embodied 1 2 in a written agreement specifying purposes, duration, means 3 of financing, methods of operations, termination, 4 acquisition and disposition of property, employment of subordinate agents, reciprocation of 5 executive and governmental immunity protections or other limitations of 6 liability with respect to public transportation programs as 7 defined in W.S. 1-39-103(a)(ii)(B) and other appropriate 8 9 provisions. 10 Section 2. This act is effective July 1, 2011. 11 12
