AN ACT relating to consumer protection; requiring the 1 disclosure of specified information in health care 2 advertising; prohibiting deceptive or 3 misleading information; providing definitions; requiring the display 4 of specified information at medical practices; providing 5 fines and penalties; and providing for an effective date. 6 7

3 in Health Care Practitioner Qualifications and Advertising

4 Act."

6 **40-12-602.** Definitions.

8 (a) As used in this act:

10 (i) "Advertisement" means billboards, brochures,

11 pamphlets, radio and television scripts, electronic media,

12 printed telephone directories, telephone and direct mail

13 solicitations and any other means of promotion intended to

14 directly or indirectly induce any person to enter into an

15 agreement for services with a health care professional;

17 (ii) "Deceptive or misleading" means misstating,

18 falsely describing or falsely holding out a health care

19 practitioner's profession, skills, training, expertise,

20 education, board certification or licensure;

22 (iii) "Health care service" means any act to

23 prevent, diagnose, correct or treat, in any manner, by any

24 means, method or device, any human disease, illness, pain,

1	wound,	fracture,	infirmity,	defect	or	abnormal	physical	or

2 mental condition, injury, deformity or ailment, or to

3 otherwise improve human physical or mental health;

6 who engages in, provides or renders health care services;

14 names a health care practitioner shall:

16 (i) Identify any health care license held by the

17 practitioner and the state in which the license was issued;

20 professional credentials include any of the following, use

21 without abbreviation the appropriate word or phrase to

22 describe the practitioner's profession, as follows:

17	40-12-604. Health care identification.						
18							
19	(a) A health care practitioner providing health care						
20	services in this state shall conspicuously post and						
21	affirmatively communicate the practitioner's specific						
22	licensure as follows:						

1 (i) If a health care practitioner wears a name 2 tag during patient encounters, the name tag shall clearly 3 identify the type of license held by the health care 4 practitioner. The name tag shall be of sufficient size and 5 be worn in a conspicuous manner so as to be visible and

apparent;

8 (ii) The health care practitioner shall display
9 in his office a writing that clearly identifies the type of
10 license held by the health care practitioner. The writing
11 shall be of sufficient size so as to be visible and
12 apparent to all current and prospective patients.

13

(b) Any health care practitioner who engages in,
provides or renders health care services in more than one
(1) practice location shall be required to comply with the
requirements of subsection (a) of this section in each
practice location.

20 40-12-605. Violations; penalties.

21

22 (a) Any person who violates this act is guilty of a 23 misdemeanor punishable by a fine of not more than five

1 hundred dollars (\$500.00), imprisonment for not more than

2 six (6) months, or both.

3

4 (b) In addition to any criminal penalties, a court

5 may assess a civil penalty of up to five thousand dollars

6 (\$5,000.00) for a violation of this act. Any penalty

7 collected under the provisions of this section shall be

8 deposited in the public school fund of the appropriate

9 county as required by article 7, section 5 of the Wyoming

10 constitution.

11

12 (c) In addition to any civil or criminal remedy

13 provided by law, upon a determination that any person has

14 violated this act, an appropriate licensing authority may

15 sanction the person or revoke or suspend any license held

16 by the person.

17

18 Section 2. This act is effective July 1, 2011.
