6 Be It Enacted by the Legislature of the State of Wyoming:

8 **Section 1.** W.S. 27-4-507(a) is amended to read:

- 10 27-4-507. Tips and gratuities; unlawful to pay lower
- 11 wage than that agreed upon; unlawful to fraudulently fail
- 12 to pay fringe benefits agreed upon.

- 14 (a) Tips and gratuities received by an employee or
- 15 employees shall be the sole property of such employee or
- 16 employees and not payable in whole or in part to the

employer or any other person provided that this requirement 1 2 shall not prevent an employer from setting and enforcing 3 policies regarding the pooling and distribution of tips and 4 gratuities among staff directly serving customers, subject 5 to the following: 6 7 (i) Food service establishment personnel directly serving customers include wait staff, bus staff, 8 9 service bartenders, hosts and counter personnel who serve 10 customers; 11 (ii) A tip and gratuity pooling and distribution 12 13 policy shall not provide for distribution of tips and gratuities to food service personnel not directly serving 14 customers, including but not limited to dishwashers, 15 kitchen staff and janitors; 16 17 (iii) Where an individual is the primary server 18 responsible for food and drinks, that individual shall not 19 20 be required to contribute more than fifteen percent (15%) 21 of tips and gratuities received by that individual to a tip 22 pool;

1	(iv) Only tips and gratuities in excess of the
2	federal minimum wage, after counting employer paid wages,
3	tips and gratuities, shall be eligible for tip pooling;
4	
5	(v) In service industries such as providers of
6	sport or recreational opportunities as defined in W.S.
7	1-1-122(a)(iii), guest ranches as defined in W. S.
8	12-1-101(a)(xxiii), vacation resorts and travel tour
9	guides, employer policies regarding pooling and
10	distribution may recognize that other types of employees,
11	in addition to those identified in paragraph (i) of this
12	subsection, are usual and customary recipients of tips and
13	gratuities.
14	
15	Section 2. This act is effective immediately upon
16	completion of all acts necessary for a bill to become law
17	as provided by Article 4, Section 8 of the Wyoming
18	Constitution.
