9	(i) "Legal tender" means an authorized medium of
10	exchange for the payment of debts and taxes;

12	(ii) "Specie" means coin or bullion having gold
13	or silver content.

15	9-4-1303. Recognition of specie legal tender.

17	(a) Specie legal tender in Wyoming consists of:

19	(i) Specie coin issued by the United States
20	government at any time;

(ii) Any other specie which a court of competent

jurisdiction, by final and unappealable order, rules to be

4 9-4-1304. Taxation issues related to legal tender.

6 (a) Legal tender including specie legal tender shall

7 not be characterized as personal property for taxation or

8 regulatory purposes.

10 (b) The exchange of one (1) type or form of legal

11 tender for another form or type of legal tender shall not

12 give rise to any tax liability of any kind.

14 (c) Any tax due resulting from any transaction

15 involving specie legal tender shall be paid in like legal
