11 **31-2-102.** Exemptions.

13 (a) No certificate of title shall be issued for:

- 15 (vii) Homemade trailers that have no identifying
- 16 number and which have an unladen weight of one thousand
- 17 (1,000) pounds or less.

5 (a) Applications for paper certificates of title or 6 electronic certificates of title, if available, shall be 7 under oath and contain or be accompanied by:

9 (vi) In the case of a vehicle registered or 10 titled in a state other than Wyoming, or any nonexempt 11 homemade vehicle, rebuilt vehicle, reconstructed vehicle, any vehicle assembled from a kit or any vehicle for which a 12 13 bond is required, a current statement made by a Wyoming law enforcement officer, or licensed Wyoming dealer only for 14 vehicles in his inventory or possession, that the vehicle 15 identification number on the vehicle has been inspected and 16 17 that the inspection occurred in Wyoming and certifying the correct vehicle identification number displayed on the 18 Any licensed Wyoming dealer performing 19 vehicle. 20 inspection of a vehicle identification number under this 21 section shall, in addition to the requirements of this act, 22 do so pursuant to W.S. 31-11-108. In the case of a vehicle not in Wyoming, the vehicle identification number may be 23 24 inspected and certified on a form approved by
