## A BILL

for

- 1 AN ACT relating to the Wyoming cultural trust fund board;

- 3 membership on the board; providing for terms; providing an

6 Be It Enacted by the Legislature of the State of Wyoming:

- 8 **Section 1.** W.S. 9-2-2305(a) (intro), (i), (ii) (intro)
- 9 and (b) is amended to read:

- 11 9-2-2305. Wyoming cultural trust fund board;
- 12 creation; members.

- 14 (a) There is created the Wyoming cultural trust fund
- 15 board. The board shall consist of five (5) eight (8)
- 16 members, as follows:

2	(i) The administrator of the division of
3	cultural resources or his designee who shall serve as an ex
4	officio member of the board, without a vote; and

6	(ii) <del>Four (4) <u>Seven (7)</u> persons appointed by the</del>
7	governor and confirmed by the senate from the following
8	nominees: who are residents of Wyoming. The members shall
9	be appointed from each of the appointment districts set
LO	forth in W.S. 9-1-218. Board membership shall reflect a
L1	broad spectrum of experiences, including, but not limited
L2	to, the arts, history, archaeology, humanities and cultural
L3	and heritage tourism.

L5	(b) Except for the <u>initial board</u> <u>board</u> members
L6	initially appointed on March 1, 2014, each appointed member
L 7	of the board shall serve for a term of three (3) years. Of
L8	the initial appointees, one (1) member shall be appointed
L9	for one (1) year, two (2) members shall be appointed for
20	two (2) years and two (2) members shall be appointed for
21	three (3) appointees initially appointed on March 1, 2014,
22	two (2) members shall be appointed for one (1) year and one
23	(1) member shall be appointed for two (2) years.
24	Thereafter each board member shall serve for a term of

1 three (3) years. The governor may remove any member as

2 provided in W.S. 9-1-202. A vacancy on the board shall be

3 filled for the balance of the unexpired term. The board

4 shall select one (1) of its members to serve as chairman.

6 **Section 2.** W.S. 9-2-2305(a)(ii)(A) and (B) is

7 repealed.

8

9 **Section 3.** There is appropriated four thousand

10 dollars (\$4,000.00) from the general fund to the Wyoming

11 cultural trust fund board. This appropriation shall be for

12 the period beginning with the effective date of this act

13 and ending June 30, 2014. This appropriation shall only be

14 expended for the purpose of staffing the cultural trust

15 fund board. Notwithstanding any other provision of law,

16 this appropriation shall not be transferred or expended for

17 any other purpose and any unexpended, unobligated funds

18 remaining from this appropriation shall revert as provided

19 by law on June 30, 2014.

21 Section 4. This act is effective March 1, 2014.
