1	AN ACT relating to the military department; creating the
2	armory maintenance account; providing for investment and
3	expenditure of funds in the account; providing criteria for
4	expenditures from the account, including federal matching
5	funds; providing an appropriation; authorizing positions;
6	and providing for an effective date.

8	Be It Enacted by the Legislature of the State of Wyoming:

10	Section 1. W.S. 19-7-207 is created to read:
11	
12	19-7-207. Armory maintenance account.
13	
14	(a) An account is established which shall be known as
15	the Wyoming military department armory maintenance account.
16	

(b) Monies for the account shall be transmitted to 1 the state treasurer for credit to the account monthly and 2 3 shall be invested by the state treasurer as authorized under W.S. 9-4-715(a), (d) and (e) in a manner designed to 4 5 obtain the highest return possible consistent with preservation of the transmitted monies. 6 Income and any interest earned from investment of the account shall be 7 credited monthly by the state treasurer to the account, are 8 9 continuously appropriated to the military department and 10 shall be expended in accordance with subsection (c) of this 11 section.

13 (c) All funds in the account, including income and 14 interest earned from the armory maintenance account, shall 15 be expended by the adjutant general subject to the 16 following:

18 (i) Funds in the account, including 19 appropriations and interest earnings, shall be used only to 20 address deferred maintenance in national guard armories;

(ii) Distributions from the account shall not
exceed five hundred thousand dollars (\$500,000.00) per
state fiscal year, commencing July 1, 2014, and shall be

expended only to the extent equal or matching federal funds 1 2 deferred armory maintenance are received by the for 3 department in the same fiscal year. 4 5 (d) Notwithstanding W.S. 9-2-1008, 9-2-1012(e) and 9-4-207, funds in the account shall not lapse or revert 6 until June 30, 2019. 7 8 9 (e) The adjutant general shall promulgate rules and administration 10 regulations for the of the armory 11 maintenance account created by this section. 12 13 Section 2. 14 15 (a) There is appropriated two million three hundred thousand dollars (\$2,300,000.00) from the general fund to 16 17 the military department. This appropriation shall only be expended for the purpose of the armory maintenance account 18 W.S. 19-7-207 created 19 pursuant to by this act. 20 Notwithstanding any other provision of law, this 21 appropriation shall not be transferred or expended for any 22 other purpose. This appropriation shall not be included in department's 2017-2018 standard 23 the biennial budget 24 request.

10	completion of all acts necessary for a bill to become law
11	as provided by Article 4, Section 8 of the Wyoming
12	Constitution.
