7 Be It Enacted by the Legislature of the State of Wyoming:

9 **Section 1.** W.S. 9-2-2709 is created to read:

9-2-2709. Substance abuse grant program.

- 13 (a) There is created a process for grants
- 14 facilitating substance abuse treatment programs. The
- 15 process shall be administered by the Wyoming department of
- 16 health.

2 The substance abuse treatment account is hereby (b) 3 created. The account shall consist of those funds appropriated to the account by the legislature. The account 4 5 specifically empowered to accept grants, gifts, transfers, bequests and donations. Funds in the account are 6 continuously appropriated to the department for the purpose 7 of providing grants under subsections (c) and (d) of this 8 9 section.

10

11 (c) The department shall establish by rule and 12 regulation an application procedure and calendar for grants 13 awarded under subsection (d) of this section and adopt 14 other rules as necessary to implement this section.

15

16 (d) The department shall provide grants, subject to 17 the following:

18

(i) Before submission to the department, and following public notice and a hearing, the application shall be approved by the city, town or county where the substance abuse program is located or proposed to be located;

(ii) Grants may be made to substance abuse 1 programs for one-time startup costs of a new center, clinic 2 3 or program, for existing centers, clinics or programs to expand the population served or initiate new services for 4 5 existing or new centers, clinics or programs to facilitate compliance with quality criteria; 6 7 (iii) Grants to any one (1) center or clinic 8 9 shall not exceed one million dollars (\$1,000,000.00) of 10 state funds; 11 (iv) Grant applications shall include evidence 12 of a commitment of local matching funds of at least ten 13 percent (10%) of the state funds grant amount in cash, in 14 kind or both; and 15 16 17 (v) Grants shall be awarded only if applicant can demonstrate an operating plan that integrates 18 abuse treatment services within the 19 substance entire service community. 20

Section 2. There is appropriated two million dollars (\$2,000,000.00) from the general fund to the substance abuse treatment account created by this act. This

1 appropriation shall only be expended for the purposes of

2 this act. Notwithstanding any other provision of law, this

3 appropriation shall not be transferred or expended for any

4 other purpose.
