1 AN ACT relating to administration of government; providing

2 counties an option to participate in the state employees'

3 and officials' group insurance plan; specifying

4 participation and contribution requirements and procedures;

5 implementing payment mechanisms for participating counties;

8 Be It Enacted by the Legislature of the State of Wyoming:

10 **Section 1.** W.S. 9-3-201(a), (e) and (f),

11 9-3-203(a)(iv), (xvi), by creating a new paragraph (xvii)

12 and by renumbering (xvii) as (xviii), 9-3-210 by creating a

13 new subsection (g) and 18-2-101(a)(vi), (viii) and by

14 creating a new paragraph (ix) are amended to read:

9-3-201. Group prepaid plans authorized; agreements
with insurance companies authorized; limitation on
authorized plans and companies; payroll deductions; selfinsurance programs; optional school district and county

participation in plan.

(a) The state of Wyoming and its political 7 8 subdivisions and school districts may obtain group prepaid 9 plans or insurance for life, health, accident 10 hospitalization for their employees and for elected officials, except for members of the legislature, and enter 11 12 into agreements with prepaid plans or insurance companies 13 to provide this coverage. Insurance coverage for school district, county or board of cooperative educational 14 services employees meeting the definition of employee under 15 16 W.S. 9-3-203(a)(iv), shall, if elected by the district, county or board under subsection (e) of this section, be 17 provided through the state employees' and officials' group 18 19 insurance plan in accordance with W.S. 9-3-202 through 20 9-3-218. Insurance coverage for retired school district, 21 county or board of cooperative educational services 22 employees shall, if elected by the board, county or district under subsection (e) of this section and if the 23

retired employee was continuously covered under the 1 2 board's, county's or district's insurance plan prior to the 3 election, be provided through the state employees' and 4 officials' group insurance plan in accordance with W.S. 9-3-202 through 9-3-218. If a school district, county or 5 board of cooperative educational services elects to cease 6 participation in the group insurance plan pursuant to 7 8 subsection (f) of this section, the election shall apply to retired employees of that board, county or district who are 9

receiving coverage under this subsection.

12 (e) Any school district, county or board 13 cooperative educational services may elect to participate 14 in the state employees' and officials' group insurance plan by filing notification of election with the department of 15 16 administration and information on a form and in a manner as prescribed by the department. Participation in the plan 17 for any electing board, county or district shall commence 18 19 not less than one hundred twenty (120) days following the 20 date on which the board, county or district filed 21 notification under this subsection and shall be identical to plans and coverage provided other enrollees under this 22 23 act. The department shall notify the electing board,

county or district of the date on which the board, county 1 2 or district is eligible to participate in the state group 3 insurance plan. An election by a board, county or district 4 to participate in the state group insurance plan under this subsection is irrevocable for a period of five (5) years 5 from the date on which plan participation originally 6 commenced. In addition to all other remedies available to 7 8 the department, if a district, county or board withdraws 9 from the state group insurance plan during the period of 10 irrevocability, the department may assess against the withdrawing board, county or district the amount by which 11 12 all claims paid on behalf of employees of the board, county 13 or district exceeds total premiums paid by the board, 14 county or district and their employees. A board, county or district may renew its initial participation in the state 15 16 group insurance plan without interruption upon submitting notification of renewal to the department prior to 17 expiration of the initial five (5) year participation 18 period. Renewal of plan participation shall be irrevocable 19 20 for an additional period of not less than five (5) years.

22 (f) Any school district, county or board of 23 cooperative educational services which has elected to

6	insurance plan by filing notification of the election to

9	prohibit the board, county or district from participation
10	in the state group insurance plan for a period of five (5)
11	years commencing on the date plan participation ceased.
12	Participation in the plan for any board, county or district

14	shall be discontinued on a date determined by the
15	department in consultation with the board, county or
16	district, but in no event later than one hundred twenty

6	amount of contributions paid under W.S. 9-3-211 for each
7	employee electing coverage shall be deducted from the
8	employee's monthly salary in accordance with W.S. 9-3-211.
