(ii) A court has entered an ex parte order for immediate detention of a person pursuant to W.S. 25-10-110.1(h);

(iii) A hospital revokes convalescent status release of a person pursuant to W.S. 25-10-127(b)."

Page 2-line 9 After "released." insert "If the person is detained following the preliminary examination, an examiner shall reexamine the person not less than every forty-eight (48) hours until the hearing under subsections (h) through (k) of this section."

Page 2-line 10 After "examination" insert ", or any reexamination as required by this subsection,".

Page 3-line 11 After "person" insert "his parent or guardian, to any attorney representing the person,".

Page 7-line 1 Delete "July 1, 2017" insert "immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.". HALVERSON, VICE-CHAIRMAN
