This appropriation shall be a continuing appropriation available from the effective date of this act until the level I and level II planning and design are completed. Appropriated funds under this subsection shall be expended only on the project specified in subsection (a) of this section and any unexpended, unobligated funds remaining at completion of the project shall revert to the general fund."
