"(e) As a condition of the appropriation of funds in subsection (a) of this section, no governing body of a city, town or county that receives a distribution shall act as a sanctuary city, town or county. Each city, town or county that receives a distribution shall certify and report its compliance with this subsection to the joint appropriations committee not later than January 1 of each year of the 2019-2020 biennium. As used in this subsection:

(i) "Immigration status information" means any information which is not confidential or privileged by law including any statement, document, computer generated data, recording or photograph that is relevant to immigration status or the identity or location of an individual who is reasonably believed to be illegally residing within the United States or involved in international or domestic terrorism as defined in 18 U.S.C. 2331;

(ii) "Sanctuary city, town or county" means a city, town or county that adopts or implements through its governing body any regulation, rule, policy or practice that prohibits or restricts local officials or employees from communicating or cooperating with federal officials or law enforcement officers with regard to reporting immigration status information while the local official or employee is acting within the scope of their official duties."
