The purpose of the meeting is to continue the Committee's interim work, as assigned by the Legislature's Management Council. The first day of the meeting the Committee will receive testimony regarding the Revenue Information System modernization and vehicle registration, fines and depreciation. The Committee will review draft legislation regarding motor service club statutory updates. The Committee will also receive reports regarding 18- to 21-year old commercial drivers' license drivers, historic license plates, farm vehicle designation, Wyoming Department of Transportation state and federal funding, bond amounts and any government or industry developments affecting transportation or highways. The second day of the meeting the Committee will review draft legislation regarding updates to statutes that affect military members, veterans' home skilled nursing care and the veterans' tuition program. The Committee will also receive reports regarding any federal or judicial developments affecting the military or veterans. Following each topic, the Committee will accept public comment.
