A BILL

for

1 AN ACT relating to motor vehicle license plates;
2 authorizing special University of Wyoming license plates;
3 specifying requirements; providing for termination of the
4 issuance and report of the termination as specified; and
5 providing for an effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** W.S. 31-2-219 is created to read:

11 **31-2-219. University of Wyoming license plates.**

13 (a) Any person required to register a vehicle in
14 Wyoming pursuant to W.S. 31-2-201 may apply to the
15 University of Wyoming alumni association for a statement of

1 eligibility for distinctive University of Wyoming license
2 plates for any motor vehicle owned by the applicant upon
3 registration of the vehicle. Upon payment by the applicant
4 of a fee, not to exceed one hundred dollars (\$100.00),
5 assessed by the association, the association shall issue a
6 written statement of eligibility for University of Wyoming
7 license plates. Application shall be made at least thirty
8 (30) days before registration of the vehicle expires.

9
10 (b) The written statement of eligibility issued under
11 subsection (a) of this section shall be presented to the
12 department before University of Wyoming license plates may
13 be issued. License plates issued under this section shall
14 be displayed upon the vehicle for which they are issued.

15
16 (c) Except as provided in this section, application
17 for, issuance and renewal of University of Wyoming license
18 plates shall be subject to the same requirements and fees
19 as provided in this article. The fee required under W.S.
20 31-3-102(a)(viii) shall accompany each application.

21
22 (d) The department shall prescribe the design of the
23 special license plate authorized by this section, which
24 shall include an image of the bucking horse and rider as

1 described in W.S. 8-3-117, in consultation with the
2 University of Wyoming alumni association and the secretary
3 of state's office, and arrange for production of the
4 license plates. Following initial approval, University of
5 Wyoming plates shall be subject to redesign on the same
6 schedule as all license plates beginning with the year 2017
7 reissuance. The license plates shall be issued by the
8 county treasurer of each county.

9
10 (e) The department may prepare any special forms and
11 issue any rules and regulations necessary to carry out this
12 section.

13
14 (f) Unless one thousand (1,000) sets of license
15 plates are issued under this section before December 31,
16 2016, the plate authorized under this section shall be
17 eliminated from production and the department of
18 transportation shall report the cessation of production to
19 the legislature not later than January 15, 2017.

21 **Section 2.** This act is effective January 1, 2007.
