A BILL

for

1 AN ACT relating to the Wyoming board of outfitters;
2 providing definitions; limiting terms of board members;
3 clarifying the board's authority to investigate and issue
4 citations; providing for loss of hunting privileges;
5 prohibiting the lease of privately owned lands for hunting
6 to unlicensed outfitters; and providing for an effective
7 date.

9 *Be It Enacted by the Legislature of the State of Wyoming:*

10

11 **Section 1.** W.S. 23-2-406(a), 23-2-407(a),
12 23-2-408(b), 23-2-410(c) by creating a new paragraph
13 (vii), 23-2-417(b) and 23-2-418 by creating a new
14 subsection (b) and by renumbering (b) as (c) are amended to
15 read:

1 **23-2-406. Definitions.**

2

3 (a) As used in this act:

4

5 (i) "Advertises" means attempting by any means,
6 including the Internet, the world wide web or a similar
7 proprietary or common carrier electronic system, to induce
8 persons to enter into an agreement with an outfitter to
9 receive guide or packing services;

10

11 ~~(i)~~(ii) "Board" means the Wyoming state board of
12 outfitters and guides established under this act;

13

14 ~~(ii)~~(iii) "Outfitter" means a person including a
15 hunting club, who advertises or holds himself out to the
16 public for hire or remuneration to provide guide or packing
17 services for the purpose of taking any big or trophy game
18 animal, excluding any person who furnishes pack or riding
19 animals and other equipment only to a hunter for his
20 personal temporary use and any landowner providing
21 outfitter services on private lands owned ~~or leased~~ by him.

22 As used in this paragraph:

23

1 (A) "Hunting club" means any person
2 requiring dues or remuneration for providing personal
3 services in the field for the taking of any big or trophy
4 game animal;

5
6 (B) "Landowner" means any person, firm or
7 corporation holding title to, or occupying under a contract
8 of purchase, agricultural land or any person whose family
9 owns at least a majority of the stock in a Wyoming
10 corporation and who provides services specified in this
11 paragraph on lands owned by the corporation and used
12 primarily for agricultural purposes.

13
14 ~~(iii)~~ (iv) "Professional guide" means any person
15 employed by or operating under an independent contract with
16 a licensed outfitter to furnish personal services for the
17 conduct of outdoor recreational activities for the purpose
18 of hunting animals except any person employed by a licensed
19 outfitter solely to care for, groom or saddle livestock,
20 cook, cut wood or to transport people, equipment and
21 personal property;

23 ~~(iv)~~ (v) "Guide or packing services" means,
24 ~~transporting~~ for hire or remuneration, ~~hunters, game~~

1 ~~animals or equipment~~ accompanying and providing assistance
2 of any kind to a hunter in the field ~~for the purpose of~~
3 related to taking of any big or trophy game animal;

5 ~~(v)~~ (vi) "This act" means W.S. 23-2-406 through
6 23-2-418.

7
8 **23-2-407. License required for outfitters and**
9 **professional guides.**

10
11 (a) No person shall hold himself out as, engage in
12 the business of or act in the capacity of an outfitter or
13 shall ~~engage in the occupation of a professional guide as~~
14 ~~an independent contractor or as an agent or employee,~~
15 provide guide or packing services unless he is licensed as
16 an outfitter or professional guide pursuant to this act.

17
18 **23-2-408. Wyoming state board of outfitters and**
19 **professional guides; membership; meetings; per diem and**
20 **travel expenses.**

21
22 (b) Appointed members shall be appointed by the
23 governor with the advice and consent of the senate in
24 accordance with W.S. 28-12-101 through 28-12-103 and may be

1 removed by the governor as provided by W.S. 9-1-202. Not
2 more than four (4) members of the board shall be of the
3 same political party. Except as otherwise provided for
4 initial appointees, the term of an appointed member shall
5 be three (3) years. After July 1, 2006, no appointed
6 member shall serve more than two (2) consecutive terms on
7 the board.

8
9 **23-2-410. Powers and duties of board; generally;**
10 **employees; licensing and regulation; issuance of citations.**

11
12 (c) The board shall license and regulate outfitters
13 and professional guides in this state and shall:

14
15 (vii) Investigate unlicensed outfitters and
16 unlicensed guides for violations of this act.

17
18 **23-2-417. Violations in general; penalties;**
19 **forfeiture.**

20
21 (b) In addition to subsection (a) of this section,
22 the court may in its discretion, revoke any license issued
23 under this act or under the Wyoming game and fish act, W.S.
24 23-1-101 through 23-6-208, to any person violating this

1 act, for the remainder of the year in which the conviction
2 occurs, and may suspend the person's privilege to receive ~~a~~
3 any license under this act and under the Wyoming game and
4 fish act, W.S. 23-1-101 through 23-6-208, for a period not
5 to exceed five (5) years.

6
7 **23-2-418. Compensation of person not licensed under**
8 **this act prohibited; lease to person not licensed under**
9 **this act prohibited; penalty.**

10
11 (b) No person shall directly or indirectly lease
12 private lands owned by him to a person holding himself out
13 as engaging in the business of or acting in the capacity of
14 an outfitter or a guide unless that person provides proof
15 that he is a licensed outfitter as required by this act.

16
17 ~~(b)~~ (c) Any person violating this section is guilty of
18 a misdemeanor as prescribed under W.S. 23-2-417(a).

19
20 **Section 2.** Nothing in this act shall affect the
21 current term of office of any board member holding office
22 at the time of passage of this act.
