(iii) Township 14 north, range 70 west, 6th p.m., section 25: W1/2 NW1/4, SE1/4 NW1/4; less .85 acres also less (20 acres) a parcel in the W1/2 of section 25, described as follows: beginning at the center 1/4 of said section 25, being monumented by a found 3 1/4" aluminum cap stamped "S.D. Dawson, LS 555"; thence south 88 degrees 15 minutes 48 seconds west, a distance of 200.45' to a found plastic cap, said point being the point of beginning; thence north 01 degree 00 minutes 39 seconds east, a distance of 407.69' to a found aluminum cap; thence south 88 degrees 18 minutes 39 seconds west, a distance of 44.12' to a point; thence south 88 degrees 18 minutes 39 seconds west, a distance of 591.46' to a point; thence north 01 degree 41 minutes 21 seconds west, a distance of 119.56' to a point; thence south 88 degrees 18 minutes 39 seconds west a distance of 1131.79' to a point; thence south 42 degrees

31 minutes 44 seconds west, a distance of 99.96' to a point; thence south 09 degrees 24 minutes 01 seconds east, a distance of 459.14' to a point; thence north 88 degrees 18 minutes 59 seconds east, a distance of 1756.27' to the point of beginning, paragraphs (i) through (iii) of this subsection containing 1,933.8 acres more or less;

(iv) Township 15 north, range 70 west, section 30: SW1/4; S1/2 NW1/4; W1/2 SE1/4; NE1/4 SE1/4; N1/2 SE1/4 SE1/4; section 31: NW1/4 containing 540 acres more or less;

(v) Township 14 north, range 70 west, section 8: N1/2 SW1/4; S1/2 S1/2; section 17: all; section 16: S1/2 N1/2 SW1/4; 1.60 acres of land in the N1/2 N1/2 SW1/4 described as follows: beginning at a point that bears south 51 degrees 32 minutes 00 seconds east a distance of 1052.1' from the west corner of said section 16; thence north 00 degrees 20 minutes 00 seconds east a distance of 160' to a point; thence north 78 degrees 50 minutes 00 seconds east a distance of 329.5' to a point; thence south 43 degrees 57 minutes 00 seconds east a distance of 260.3' to a point; thence south 89 degrees 35 minutes 00 seconds west a distance of 462.8' to the point of beginning; containing 921.6 acres more or less.

2 **Section 2.** This act is effective immediately upon
3 completion of all acts necessary for a bill to become law
4 as provided by Article 4, Section 8 of the Wyoming
5 Constitution.
