A BILL

for

1 AN ACT relating to judicial salaries; increasing judicial  
2 salaries as specified; providing an appropriation; and  
3 providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 5-1-110(a)(i) through (iii) is  
8 amended to read:

10 **5-1-110. Salaries of judges.**

11

12 (a) Subject to constitutional and statutory  
13 provisions concerning when salaries can become effective,  
14 judges of the supreme court, district courts and circuit  
15 courts shall receive the following annual salaries which

1 shall be paid in equal monthly installments on the last  
2 working day of the month:

4 (i) Supreme court justices shall receive an  
5 annual salary of ~~one hundred eight thousand two hundred~~  
6 ~~dollars (\$108,200.00) commencing July 1, 2004~~ one hundred  
7 fifteen thousand three hundred dollars (\$115,300.00)  
8 commencing July 1, 2006, and ~~one hundred eleven thousand~~  
9 ~~four hundred dollars (\$111,400.00) commencing July 1, 2005~~  
10 one hundred nineteen thousand three hundred dollars  
11 (\$119,300.00) commencing July 1, 2007;

12  
13 (ii) District court judges shall receive an  
14 annual salary of ~~one hundred three thousand dollars~~  
15 ~~(\$103,000.00) commencing July 1, 2004~~ one hundred nine  
16 thousand eight hundred dollars (\$109,800.00) commencing  
17 July 1, 2006, and ~~one hundred six thousand one hundred~~  
18 ~~dollars (\$106,100.00) commencing July 1, 2005~~ one hundred  
19 thirteen thousand six hundred dollars (\$113,600.00)  
20 commencing July 1, 2007;

22 (iii) Circuit court judges shall receive an  
23 annual salary of ~~eighty four thousand five hundred dollars~~  
24 ~~(\$84,500.00) commencing July 1, 2004~~ ninety thousand

1 dollars (\$90,000.00) commencing July 1, 2006, and ~~eighty-~~  
2 ~~seven thousand dollars (\$87,000.00) commencing July 1, 2005~~  
3 ninety-three thousand two hundred dollars (\$93,200.00)  
4 commencing July 1, 2007.

5  
6       **Section 2.** In addition to any other appropriation to  
7 the supreme court, there is appropriated from the general  
8 fund to the supreme court six hundred ninety-one thousand  
9 four dollars (\$691,004.00) to implement the salary formula  
10 for judges established under this act.

12       **Section 3.** This act is effective July 1, 2006.
