State veterans' memorial museum.

A BILL

for

1 AN ACT relating to the state veterans' memorial museum;
2 transferring oversight of the state veterans' memorial
3 museum to the military department; repealing designation as
4 state historic site; and providing for an effective date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 19-7-107 is created to read:

9

10 **19-7-107. Description and declaration of Wyoming**
11 **Veterans' Memorial Museum.**

12

13 The lands in Natrona county described as follows are hereby
14 declared to be the Wyoming veterans' memorial museum to be
15 managed by the military department: a parcel of land
16 situate in the NE¼ of the SE¼ and the SE¼ of the NE¼ of

1 Section 20, Township 34 North, Range 80 West, 6th P.M.,
2 Natrona County, Wyoming, said parcel being more
3 particularly described as follows: commencing at the
4 southeast corner of said Section 20, monumented by a brass
5 cap; thence N01°27'16"W, a distance of 2597.39 feet to the
6 southeast corner of the parcel monumented by a nail and
7 being the point of beginning; thence S43°17'47"W, a distance
8 of 163.93 feet to the southwest corner of the parcel,
9 monumented by a nail; thence N46°42'21"W, a distance of
10 359.92 feet to the northwest corner of the parcel,
11 monumented by a nail; thence N43°17'47"E, a distance of
12 163.93 feet to the northeast corner of the parcel,
13 monumented by a nail; thence S46°42'21"E, a distance of
14 359.92 feet to the point of beginning, containing 1.35
15 acres, more or less.

17 **Section 2.** W.S. 36-4-121(p) and 36-8-1301 are
18 repealed.

20 **Section 3.**

22 (a) It is the intention and direction of the
23 legislature that:

1

2 (i) All duties of the department of state parks
3 and cultural resources with respect to the Wyoming
4 veterans' memorial museum be transferred to the Wyoming
5 military department. Effective July 1, 2007, all duties of
6 the department of state parks and cultural resources with
7 respect to the Wyoming veterans' memorial museum not
8 assumed by the military department are terminated;

9

10 (ii) Any appropriated or unexpended funds not
11 otherwise obligated and any other property, if any, of the
12 department of state parks and cultural resources
13 exclusively dedicated to the Wyoming veterans' memorial
14 museum be transferred to the military department;

15

16 (iii) Any contract, agreement or obligation
17 entered into or assumed by the department of state parks
18 and cultural resources with respect to the Wyoming
19 veterans' memorial museum, if the execution or assumption
20 was within the lawful powers of the department of state
21 parks and cultural resources, be assumed by the military
22 department;

23

1 (iv) Any policy adopted by the department of
2 state parks and cultural resources with respect to the
3 Wyoming veterans' memorial museum remain in effect
4 unaltered as policy of the military department until
5 amended or repealed by the military department.

6

7 **Section 4.** This act is effective July 1, 2007.
