## A BILL

for

- 1 AN ACT relating to the state veterans' museum; transferring
- 2 oversight of the state veterans' memorial museum to the
- 3 military department; repealing museum designation as a
- 4 state park; providing for the disposition of unexpended
- 5 funds and other property; and providing for an effective
- 6 date.

8 Be It Enacted by the Legislature of the State of Wyoming:

10 **Section 1.** W.S. 19-7-107 is created to read:

11

- 12 19-7-107. Description and declaration of Wyoming
- 13 veterans' memorial museum.

- 15 The lands in Natrona county described as follows are hereby
- 16 declared to be the Wyoming veterans' memorial museum to be

- 1 managed by the military department: a parcel of land
- 2 situate in the NE% of the SE% and the SE% of the NE% of
- 3 Section 20, Township 34 North, Range 80 West, 6th P.M.,
- 4 Natrona County, Wyoming, said parcel being more
- 5 particularly described as follows: commencing at the
- 6 southeast corner of said Section 20, monumented by a brass
- 7 cap; thence N01°27'16"W, a distance of 2597.39 feet to the
- 8 southeast corner of the parcel monumented by a nail and
- 9 being the point of beginning; thence S43°17'47"W, a distance
- 10 of 163.93 feet to the southwest corner of the parcel,
- 11 monumented by a nail; thence N46°42'21"W, a distance of
- 12 359.92 feet to the northwest corner of the parcel,
- 13 monumented by a nail; thence N43°17'47"E, a distance of
- 14 163.93 feet to the northeast corner of the parcel,
- 15 monumented by a nail; thence S46°42'21"E, a distance of
- 16 359.92 feet to the point of beginning, containing 1.35
- 17 acres, more or less.

1 (a) It is the intention and direction of the 2 legislature that: 3

4 All duties of the department of state parks (i) 5 cultural resources with respect to the Wyoming veterans' memorial museum be transferred to the Wyoming 6 7 military department. All duties of the department of state parks and cultural resources with respect to the Wyoming 8 9 veterans' memorial museum not assumed by the military 10 department are terminated;

11

12 funds (ii) All unexpended not otherwise obligated and any other property, if any, of the department 13 of state parks and cultural resources exclusively dedicated 14 to the Wyoming veterans' memorial museum be transferred to 15 16 the military department;

17

18 (iii) Any contract, agreement or obligation 19 entered into or assumed by the department of state parks 20 cultural resources with respect to the 21 veterans' memorial museum, if the execution or assumption 22 was within the lawful powers of the department of state parks and cultural resources, be assumed by the military 23 24 department, except that the military department shall enter

1 into a new lease agreement with the Natrona County Board of

2 County Commissioners for the lease of the building where

3 the museum is located;

5 (iv) Any policy adopted by the department of

6 state parks and cultural resources with respect to the

7 Wyoming veterans' memorial museum remain in effect

8 unaltered as policy of the military department until

9 amended or repealed by the military department.

11 **Section 4.** This act is effective immediately upon

12 completion of all acts necessary for a bill to become law

13 as provided by Article 4, Section 8 of the Wyoming

14 Constitution.
