A BILL

for

1	AN ACT relating to elections; providing for transmission of
2	certifications; providing for registration prior to an
3	election; providing for full legal names on registrations;
4	removing certain filing fees as specified; providing for
5	the order of offices on nonpartisan and partisan ballots;
6	providing for opening of ballot boxes; removing requirement
7	that county attorneys conduct training school; repealing
8	provisions for folded ballots; clarifying time periods;
9	repealing requirements for numbers of ballots to be
10	printed; repealing provisions related to voting slips; and
11	providing for an effective date.

13	Be It Enacted by the Legislature of the State of Wyoming:

15 **Section 1.** W.S. 22-2-108, 22-3-102(a)(intro),

16 22-3-103(a)(i), 22-3-104(j), 22-5-208(c), 22-6-101,

4 (a) The county clerk shall furnish voter registration 5 oath forms to registry agents which forms shall require the 6 following voter information from the applicant:

8 (i) His full legal name;

10 22-3-104. Methods of verification; signing oath; time
11 for proving eligibility; registration locations.

13 (j) A county or city clerk may establish and maintain 14 registration facilities in a public building area owned or 15 occupied by a political subdivision or governmental institution, agency or entity, after giving not less than 16 17 two (2) days notice by publication in a newspaper of general circulation in the county and by posting such 18 19 notice in such clerk's office. and on the front door of 20 such public building. The requirements of subsection (h) of 21 this section regarding the place of registration shall not 22 apply to a person registering in accordance with this subsection. 23

1 (a) The general election partisan ballot shall be 2 printed in substantial compliance with this format: 3 4 (vii) The names of partisan party candidates, if 5 candidates have filed, and independent candidates, if candidates have filed, shall be printed in a separate 6 7 column or columns, row or rows, and the name of the party represented or the word "Independent" shall be printed 8 9 directly above the candidate's name or at the end of the 10 row. If there are a number of candidates representing a 11 party, or independents, the county clerk at his discretion may designate a separate vertical column or columns, or row 12 13 or rows to said candidates and print the name of said party 14 or the word "Independent" at the top of the column or 15 beginning of the row; 16 17 22-6-125. Order of offices and ballot propositions on 18 nonpartisan ballots. 19 20 (a) The nonpartisan ballot shall contain the offices 21 and ballot propositions to be voted on in the following 22 order: 23

22	unable to complete his duties, the vacancy shall be filled
23	by a registered elector appointed by those judges present
24	at the precinct polling place when the vacancy occurs and

2 board is not present when the polls close, or is unable to

3 complete his duties, the vacancy shall be filled by a

4 registered elector appointed by those members of the

7 22-8-113. Training schools; generally and payment for

8 attending.

9

Not later than four (4) days before the primary and general 10 11 election, the county clerk under the direction of the secretary of state and the county attorney shall conduct a 12 13 training school for judges of election and members of 14 counting boards to provide instruction in the performance of their duties. The training school, which is also open 15 16 to the public, shall be held at the times and places 17 announced by the county clerk, and the secretary of state shall prescribe the minimum curriculum for the school. 18 19 Additional schools may be held at the discretion of the 20 county clerk. Unless training is otherwise provided to the 21 satisfaction of the county clerk, all judges of election 22 and members of counting boards are obligated to attend at least one (1) such school. All judges and members of the 23 24 counting board shall be paid not less than five dollars

1 (\$5.00) nor more than twenty-five dollars (\$25.00) as

2 determined by the board of county commissioners for

3 attending a school.

5 22-10-108. Procedure for preparing machines for 6 election; inspection and certification.

7

8 (a) Before preparing a voting machine for an 9 election, the county clerk shall mail a written notice to 10 notify in writing the county chairman of each political 11 party having a candidate on the ballot, stating the time and place where the voting machine will be prepared for the 12 13 election. The political party representatives 14 representatives of independent candidates may be present at the preparation of the voting machine for the election, to 15 16 see that the machine is tested for accuracy and is properly 17 prepared and that all registering counters are set at zero The county clerk in the presence of these 18 (00000). 19 representatives shall prepare the voting machine for the 20 election and set all registering counters at zero (00000). 21 He shall then test each registering counter for accuracy by 22 casting votes on it until the registering counter is 23 correctly registering each vote cast on it. The county 24 clerk shall then reset each registering counter to zero

- 1 (00000) and shall immediately lock and seal the voting
- 2 machine with a numbered metal seal and make a record of the
- 3 number of the seal on the certificate for the machine. The
- 4 seal shall be so placed as to prevent operation of the
- 5 machine or its registering counters without breaking the
- 6 seal. The county clerk shall then immediately make a
- 7 record on the certificate for the machine of the reading
- 8 shown on the protective counter.

10 **22-12-107.** Materials for judges.

- 12 (a) Before election day the county clerk shall cause
- 13 to be delivered to one (1) of the judges of election in
- 14 each precinct the following materials:

15

- 16 (iv) Ballot boxes in the number required by law
- 17 with secure locks and keys and one (1) opening sufficient
- 18 to admit a single folded ballot;

- 20 **22-12-112.** Procedure for preparing voting machines
- 21 for use.

- 23 Before the polls open the judges shall compare ballot
- 24 labels on the voting machines with the sample ballots and

1 return sheets to see that they are correct, place the 2 voting machine in a proper position free from obstruction 3 and assure that the face of the machine may be viewed 4 clearly except when the curtain on the machine is closed 5 for casting ballots by the voter casting the ballot but not by others. Envelopes containing keys shall not be opened 6 7 if the numbers and records on them do not correspond to the numbers and records on the machine. If the numbers do not 8 9 agree, the machine shall be reexamined and certified by the 10 county clerk before it may be used.

22-12-115. Examination of ballot box.

13

14 Before the polls are open, the judges of election shall 15 open and examine the ballot box to determine that it is empty and relock it. The ballot box shall not again be 16 17 opened until the polls are closed, except when necessitated 18 by operation of the voting equipment at the direction of 19 the county clerk and only in the presence of two (2) or 20 more election judges. It shall not be removed from the 21 presence of the judges of election or counting board until 22 all ballots are counted and recorded.

24 22-13-106. Marking and depositing of paper ballots.

- 2 Upon receiving a paper ballot, an elector shall proceed
- 3 alone directly to a voting booth and there mark the ballot.
- 4 After being marked, the paper ballots shall be folded with
- 5 the face concealed and the official endorsement visible.
- 6 The ballot shall then immediately be placed in the ballot
- 7 box by the elector or judge of election.

9 22-16-103. County canvass procedures.

11 (c) The county canvassing board shall:

12

- 13 (vi) Cause minutes of the meeting to be recorded
- 14 <u>taken</u>, signed by the canvassing board and filed with the
- 15 county clerk.

17 **22-16-106.** Write-in candidates.

18

- 19 (b) The chief election officer shall notify write-in
- 20 candidates who have been nominated for election within
- 21 forty-eight (48) hours after the canvassing board meets.
- 22 Notification may be made by United States postal service,
- 23 any generally accepted business document delivery method
- 24 evidenced by receipt of delivery or attempted delivery at

1 the last known address of the write-in candidate or service

2 as accepted provided under the Wyoming Rules of Civil

3 Procedure. Failure of the successful write-in candidate to

4 accept the nomination within five (5) days, as computed

5 pursuant to W.S. 22-2-110, of proof of service or attempted

6 delivery results in the successful write-in candidate not

7 appearing on the general election ballot, but does not

8 result in a vacancy which can be filled.

9

10 **Section 2.** W.S. 22-1-102(a) (xxxiv)(A),

22-6-117(a)(x), 22-6-129, 22-13-108 and 22-13-111 are

12 repealed.

14 **Section 3.** This act is effective immediately upon

15 completion of all acts necessary for a bill to become law

16 as provided by Article 4, Section 8 of the Wyoming

17 Constitution.
