7 Be It Enacted by the Legislature of the State of Wyoming:

- 11 (a) There is appropriated eight hundred forty-eight
- 12 thousand dollars (\$848,000.00) from the general fund to the
- 13 department of health for the biennium beginning July 1,
- 14 2008 and ending June 30, 2010. The department of health
- 15 shall use the funds appropriated under this section as
- 16 follows:

2 (i) Four hundred forty thousand dollars 3 (\$440,000.00) to contract with two (2) persons whose duties 4 shall include the detection and identification of soldiers 5 returning from duty in the Iraq or Afghanistan conflicts and their families who may be in need of mental health or 6 substance abuse treatment services. The contractors shall 7 assist eligible persons identified as having potential or 8 9 actual mental health or substance abuse problems to obtain 10 assessments of and treatment for the mental health or 11 substance abuse problems;

13 (ii) Sixty-eight thousand dollars (\$68,000.00) 14 to reimburse physicians who provide assessment screenings to soldiers and their families under paragraph (i) of this 15 subsection and who are not otherwise paid for the screening 16 17 tool used in the assessment. The funds under 18 paragraph shall be used only to pay for the screening tool 19 used by the physician. Reimbursements under this paragraph 20 shall be paid to the physicians providing the assessment 21 screenings under a voucher system administered by the 22 department;

1 (iii) Two hundred fifty thousand dollars 2 (\$250,000.00) to reimburse soldiers and their families 3 under paragraph (i) of this subsection for travel, 4 childcare and other expenses necessary to access mental 5 health or substance abuse treatment resources, when the expenses are not otherwise reimbursed from another source. 6 7 Reimbursements under this paragraph shall be paid to the 8 soldier under a voucher system administered by the 9 department; 10 11 (iv) Forty thousand dollars (\$40,000.00) to provide training to physicians and other health care 12 13 providers on war related injuries and illnesses to ensure 14 the use of best practices in Wyoming; 15 16 (v) Fifty thousand dollars (\$50,000.00) 17 provide training to community leaders and employers to improve reintegration and transition into the community and 18 employment for soldiers under paragraph (i) of this 19 20 subsection. 21 22 **Section 2.** This act is effective July 1, 2008. 23 24 (END)
