for

1 AN ACT relating to the personal opportunities with
2 employment responsibilities program; increasing assistance
3 levels and allowing for annual adjustments; amending
4 eligibility requirements by removing a limit on the value
5 of excluded motor vehicles; and providing for an effective
6 date.

8 *Be It Enacted by the Legislature of the State of Wyoming:*

10 **Section 1.** W.S. 42-2-103(e)(iii) and 42-2-109(b) are
11 amended to read:

13 **42-2-103. Provision of assistance and services;**
14 **duties of department; burial assistance; state supplemental**
15 **security income program.**

(e) In administering this section and in addition to other requirements imposed under this chapter and the Wyoming Medical Assistance and Services Act and federal rule and regulation, the department shall by rule and regulation:

(iii) Limit assistance payable under W.S. 42-2-104 for the year 2008 as follows: ~~provided no assistance unit shall at any time subsequent to initial qualification for assistance receive any increase based upon an increase in the number of persons in the assistance unit after ten (10) months following initial qualification for assistance.~~
