7 subsection (a) of this section may receive reimbursement

8 for premiums paid by the member during the previous

9 calendar year for servicemembers group life insurance or

10 state sponsored life insurance, with a coverage amount of

11 up to two hundred fifty thousand dollars (\$250,000.00).

12 Premiums for members of the qualified member's family and

13 premiums paid or reimbursed by the United States shall not

14 be reimbursed.
