A BILL

for

1 AN ACT relating to salaries of public officials; increasing
2 salaries for certain public officials as specified;
3 providing an appropriation; providing for applicability of
4 the act; and providing for an effective date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 5-1-110(a)(i) through (iii) are
9 amended to read:

11 **5-1-110. Salaries of judges.**

12

13 (a) Subject to constitutional and statutory
14 provisions concerning when salaries can become effective,
15 judges of the supreme court, district courts and circuit
16 courts shall receive the following annual salaries which

1 shall be paid in equal monthly installments on the last
2 working day of the month:

4 (i) Supreme court justices shall receive an
5 annual salary of ~~one hundred nineteen thousand three~~
6 ~~hundred dollars (\$119,300.00) commencing July 1, 2007~~ one
7 hundred twenty-six thousand five hundred dollars
8 (\$126,500.00) commencing July 1, 2008 and one hundred
9 thirty-one thousand five hundred dollars (\$131,500.00)
10 commencing July 1, 2009;

11
12 (ii) District court judges shall receive an
13 annual salary of ~~one hundred thirteen thousand six hundred~~
14 ~~dollars (\$113,600.00) commencing July 1, 2007~~ one hundred
15 twenty thousand four hundred dollars (\$120,400.00)
16 commencing July 1, 2008 and one hundred twenty-five
17 thousand two hundred dollars (\$125,200.00) commencing July
18 1, 2009;

20 (iii) Circuit court judges shall receive an
21 annual salary of ~~ninety-three thousand two hundred dollars~~
22 ~~(\$93,200.00) commencing July 1, 2007~~ ninety-eight thousand
23 eight hundred dollars (\$98,800.00) commencing July 1, 2008

1 and one hundred two thousand eight hundred dollars
2 (\$102,800.00) commencing July 1, 2009.

4 **Section 2.** There is appropriated one million one
5 hundred sixty-four thousand three hundred eighty dollars
6 and twenty-six cents (\$1,164,380.26) from the general fund
7 to the supreme court. This appropriation shall be for the
8 period beginning with the effective date of this act and
9 ending June 30, 2010. This appropriation shall only be
10 expended for the purpose of implementing the judicial
11 salary increases authorized by this act. Notwithstanding
12 any other provision of law, this appropriation shall not be
13 transferred or expended for any other purpose and any
14 unexpended, unobligated funds remaining from this
15 appropriation shall revert as provided by law on June 30,
16 2010.

18 **Section 3.** This act is effective July 1, 2008.
