A BILL

for

1 AN ACT relating to the Wyoming Controlled Substances Act;
2 adding specified controlled substances to Schedule I of the
3 act; and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 35-7-1014(d)(xlii) by creating new
8 subparagraphs (G) through (N) and by creating new
9 paragraphs (xliii) through (liv) is amended to read:

11 **35-7-1014. Substances included in Schedule I.**

13 (d) *Hallucinogenic substances.* - Unless specifically
14 excepted or unless listed in another schedule, any
15 material, compound, mixture or preparation which contains
16 any quantity of the following hallucinogenic substances,
17 their salts, isomers and salts of isomers whenever the

1 existence of these salts, isomers and salts of isomers is
2 possible within the specific chemical designation (for
3 purposes of this paragraph only, the term "isomer" includes
4 the optical, position and geometric isomers):

1 **Section 2.** This act is effective immediately upon
2 completion of all acts necessary for a bill to become law
3 as provided by Article 4, Section 8 of the Wyoming
4 Constitution.
