1. Of this general fund appropriation, one hundred thousand dollars (\$100,000.00) shall only be expended if there is a change of governor as a result of the 2014 general election and then only for transition staff salaries, travel, expenses incurred in relocating to and from the governor's mansion and other related office expenses. Notwithstanding any other provision of law, these funds shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2016.

2. Of this general fund appropriation, twenty thousand dollars (\$20,000.00) shall only be expended for purposes of defraying moving expenses for gubernatorial appointees who are required to move to Cheyenne. These funds shall only be expended if there is a change of governor as a result of the 2014 general election.

1 Not more than five thousand dollars (\$5,000.00) shall be
2 expended for any one (1) appointee. Notwithstanding any other
3 provision of law, these funds shall not be transferred or
4 expended for any other purpose and any unexpended, unobligated
5 funds remaining from this appropriation shall revert as provided
6 by law on June 30, 2016.

8 3. (a) Of this general fund appropriation, two hundred
9 thousand dollars (\$200,000.00) shall only be effective for the
10 period July 1, 2014 through June 30, 2015, and two hundred
11 thousand dollars (\$200,000.00) shall be deposited in a reserve
12 account within the state auditor's office available for
13 expenditure only upon further action of the legislature. The
14 governor's office shall develop a list of deliverables for the
15 tribal liaisons prior to the expenditure of any funds in this
16 line item. The tribal liaisons shall report to the governor and
17 the joint appropriations interim committee not later than
18 November 1, 2014 outlining how the deliverables required by the
19 governor's office will be achieved.

20 (b) The deliverables under subsection (a) of this footnote
21 for tribal relations shall be implemented not later than June
22 30, 2015 and shall encourage the development of:

23 (i) Mutual respect, understanding and leadership
24 relations between the Indian tribes and the state of Wyoming;

25 (ii) Protocols and a process for communication
26 between the tribes and the state including a liaison in the
27 office of the governor to resolve communication problems;

28 (iii) A working document including an accord or
29 memorandum which clearly outlines the relationship between the
30 tribes and the state;

31 (iv) A systematic review process for tribal liaisons
32 and state government to assess successes, opportunities and
33 future issues including relationships with both the select
34 committee on tribal relations and the leadership of the
35 legislature.

36 4. This general fund appropriation shall be deposited into the
37 federal natural resource policy account created by W.S. 9-4-
38 218(a).

39
40 5. Of this general fund appropriation, one million two hundred
41 thousand dollars (\$1,200,000.00) shall only be expended for

1 purposes of sage grouse research and advancing the state's
2 position, as determined by the governor, with respect to
3 potential endangered species listing of the sage grouse by the
4 United States fish and wildlife service. Notwithstanding any
5 other provision of law, this appropriation shall not be expended
6 for any other purpose and any unexpended, unobligated funds
7 remaining from this appropriation shall revert to the general
8 fund on June 30, 2016. This appropriation shall not be included
9 in the governor's office 2017-2018 standard budget request.

10
11 6. Of this general fund appropriation, thirty-five thousand
12 dollars (\$35,000.00) shall only be expended for purposes of
13 securing in-market representation in Taiwan.".
